**I-EYE STORAGE LLC’S ANNUAL UPDATE TO ITS EMERGENCY OPERATIONS
PLAN PURSUANT TO PUC SUBST. R. 25.53(c)(3) FOR 2024**

I-Eye Storage LLC (“I-Eye”) hereby submits its annual Emergency Operations Plan (“EOP”) update pursuant to 16 Tex. Admin. Code (“TAC”) § 25.53(c)(3). This update applies to I-Eye Storage LLC (PGC Certification No. 20752). As supported by the attached Affidavit, I-Eye made no changes to its EOP in the previous calendar year that materially affect how it would respond to an emergency. I-Eye continues to comply with all applicable provisions of 16 TAC § 25.53 regarding its existing EOP that was previously submitted to the PUCT and to ERCOT.

As required by 16 TAC § 25.53(c)(3)(B), I-Eye notes it has made the following changes to its emergency contact list:

- Removal of previously reported Principal, VP of Engineering, and Director of Operations
- Addition of current SVP of Asset Management, Director of Interconnection, and Asset Manager

I-Eye provides its current emergency contact list as confidential Exhibit A to this filing. I-Eye also provides a current record of distribution as Exhibit B to this filing.

Lastly, I-Eye has attached both an Attestation of its highest-ranking representative in compliance with 16 TAC § 25.53(c)(3)(B)(ii) and an affidavit of its highest-ranking representative in compliance with 16 TAC § 25.53(c)(4)(C).

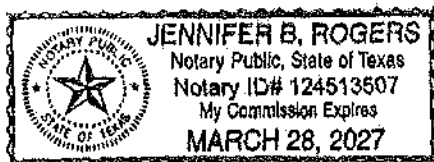

Code ("TAC") § 25.53(c)(4)(C), I further swear and affirm that: (i) all relevant operating personnel are familiar with and have received training on the applicable contents and execution of the EOP, and such personnel are instructed to follow the applicable portions of the EOP except to the extent deviations are appropriate as a result of specific circumstances during the course of an emergency; (ii) the EOP has been reviewed and approved by the appropriate executives; (iii) drills will be conducted to the extent required by 16 TAC § 25.53(f); (iv) the EOP or an appropriate summary will be distributed to local jurisdictions prior to commercial operation, as needed; (v) that I-Eye Storage maintains a business continuity plan that addresses returning to normal operations after disruption caused by an incident; and (vi) I-Eye Storage's emergency management personnel who are designated to interact with local, state, and federal emergency management officials during emergency events will receive the latest IS-100, IS-200, IS-700, and IS-800 National Incident Management Systems training prior to commercial operation of the facility.

I further swear or affirm the information, statements and/or representations contained in the EOP are true, complete, and correct to the best of my knowledge and belief.

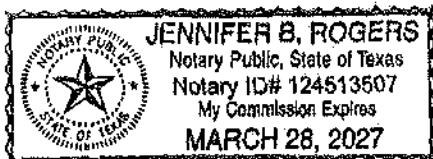
