
**PP JAGUAR BESS LLC'S



BEFORE ME, the undersigned authority, on this day personally appeared who swore an oath that the following facts are true:

1. My name is Anthony Maselli, P.E. I am Chief Executive Officer of Perfect Power LLC and the highest-ranking representative, official, or officer with binding authority over PP Jaguar BESS LLC ("PP Jaguar BESS"). I am over 18 years of age, of sound mind, and competent and authorized to make this affidavit on behalf of PP Jaguar BESS. I have personal knowledge of the matters described herein.
2. PP Jaguar BESS is registered with the Public Utility Commission of Texas as a power generation company and an indirect subsidiary of Perfect Power LLC. The PP Jaguar BESS facility is a battery energy storage system that is not yet operational.
3. PP Jaguar BESS filed an emergency operations plan (the "Plan") in accordance with 16 Texas Administrative Code ("TAC") § 25.53 on June 21, 2024.
4. An annual review of the Plan was completed, and no changes were made to the Plan in 2024 that materially affect how PP Jaguar BESS would respond to an emergency.
5. All relevant operating personnel are familiar with and have received training on the applicable contents and execution of the Plan, and such personnel are instructed to follow the applicable portions of the Plan except to the extent deviations are appropriate as a result of specific circumstances during the course of an emergency.
6. The Plan has been reviewed and approved by the appropriate executives.
7. Per 16 TAC § 25.53(f), PP Jaguar BESS will conduct a drill in the first calendar year of operations.
8. The Plan or an appropriate summary has been distributed to local jurisdictions as needed.
9. PP Jaguar BESS maintains a business continuity plan that addresses returning to normal operations after disruptions caused by an incident.
10. PP Jaguar BESS's emergency management personnel who are designated to interact with local, state, and federal emergency management officials during emergency events have received the latest IS-100, IS-200, IS-700, and IS-800 National Incident Management System training.


