COF has a Business Continuity Plan related to returning to normal operations after an emergency event or situation;



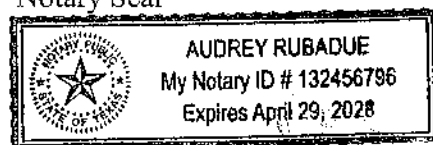

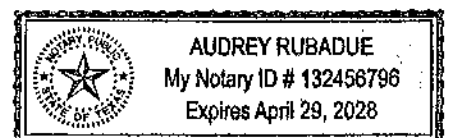
