If severe weather is forecast or has the potential to move over LCRA's operating area, notifications are sent from Public Safety Dispatch as well as the LCRA staff meteorologist via email and text messages. The LCRA Emergency Management Coordinator can also send email and text notifications to the LCRA Incident Management team as described in the LCRA Emergency Management Master Plan. 

However, the drills that LCRA has conducted as of the date of this affidavit preceded the revisions to 16 TAC § 25.53, including the revised notice requirements in 16 TAC § 25.53(f). Accordingly, 30 days' prior notice of those drills was not provided to commission staff. LCRA will provide notice of any additional drills to be performed in calendar year 2022 in accordance with new 16 TAC § 25.53(f).
- (iv) The EOP or an appropriate summary has been distributed to local jurisdictions as needed.
- (v) LCRA maintains a business continuity plan that address returning to normal operations after disruptions caused by an incident.
- (vi) Emergency management personnel who are designated to interact with local, state, and federal emergency management officials during emergency events have received the latest IS-100, IS-200, IS-700, and IS-800 National Incident Management System training."
