- I, James Staggs, am Senior Manager of Walmart Inc. and I have binding authority on behalf of Walmart Stores Texas, LLC (Walmart Stores), a Public Utility Commission of Texas (Commission or PUC) certified power generation company (PGC) in the Electric Reliability Council of Texas (ERCOT).
- 2. This affidavit is being submitted with Walmart Stores' Initial EOP as required by 16 TAC § 23.53(c)(4)(C)(i)-(vi) (aka P.U.C. Subst. R. § 25.35(c)(4)(C)).

- 7. Walmart Stores' EOP and/or Executive Summary has been distributed to local jurisdictions as needed.
- 8. Walmart Stores has a business continuity plan that addresses returning to normal operations after disruptions caused by an incident.
- 9. Walmart Stores' designated personnel to interact with local, state, and federal emergency management officials has received the IS-100, IS-200, IS-700, and IS-800 NIMS training.
- 10. A complete copy of Walmart Stores' Initial EOP has been filed at the PUC with all confidential portions removed, pursuant to the 16 TAC § 23.53(c)(1)(ii).
