**Supplement to Blevins Solar, LLC Annual Update  
PUCT Project No. 53385**

Blevins Solar, LLC (“Blevins Solar”) filed its initial Emergency Operations Plan (“EOP”) on August 27, 2024.<sup>1</sup> Blevins Solar has since made material changes to its EOP and therefore submitted an updated EOP on May 23, 2025 as part of its annual update requirement.<sup>2</sup> Blevins Solar respectfully submits this supplement to its annual update to provide additional information consistent with 16 Tex. Admin. Code § 25.53(c)(3)(A)(i).

Blevins Solar supplements its Executive Summary to additionally indicate that its EOP has been updated to reflect changes in the project’s design, emergency response procedures, and/or operational readiness measures. The updated EOP has been submitted accordingly to ensure compliance with the requirements of the Public Utility Commission of Texas and ERCOT. Blevins Solar also supplements its Executive Summary to include the following:
