AFFIDAVIT
OF COMPLIANCE WITH EMERGENCY OPERATIONS PLAN REQUIREMENTS
(Pursuant to 16 Texas Administrative Code §25.53)

BEFORE ME, the undersigned authority, on this day personally appeared:

Ravi Thuraisingham,

whose address is **330 Bay Street, Suite 600, Toronto, ON, M5H 2S8,**

and who is the **President** of **Nexus Renewables U.S. Inc.**, and being by me duly sworn,
upon oath stated as follows:

1. My name is **Ravi Thuraisingham**. I am over the age of eighteen (18), of sound mind, and competent to make this affidavit. I am personally familiar with the facts stated herein and they are true and correct.
2. I am authorized to represent **Brazos River BESS LLC**, under the parent company **Nexus Renewables U.S. Inc.** ("the Company"), which is the developer and operator of the Battery Energy Storage System (BESS) project located in Texas and registered with the Electric Reliability Council of Texas (ERCOT).
3. The Company is subject to the requirements of the **Public Utility Commission of Texas (PUCT)** under **16 Texas Administrative Code (TAC) §25.53**, which pertains to Emergency Operations Plans.
4. The Company has prepared and adopted an **Emergency Operations Plan (EOP)** for the **Brazos River BESS** project. This EOP complies with the requirements of 16 TAC §25.53 and includes, at a minimum, procedures addressing:
 - Loss of electric power supply;
 - Communication system failures;
 - Emergency staffing protocols;
 - Facility access during emergencies;
 - Backup power capability;
 - Coordination with ERCOT and applicable transmission or distribution utilities;
 - Plan review and training for operational personnel.

5. The Company affirms that the Emergency Operations Plan:

- Is current and accurate as of the date of this affidavit;
- Is available for inspection by the Commission upon request;
- Is known and accessible to operational management and key site personnel;
- Will be reviewed and updated annually, or more frequently if required by operational or regulatory changes.

6. The Company further affirms that **Brazos River BESS LLC's emergency management personnel**, designated to interact with local, state, and federal emergency management officials during emergency events, have completed the most recent **IS-100, IS-200, IS-700, and IS-800 National Incident Management System (NIMS)** training courses.



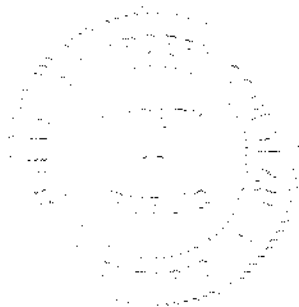
