Please accept for filing in the above-referenced proceeding an abbreviated Emergency Operations Plan ("EOP") and supporting affidavit for AmeriPower LLP ("AmeriPower"). An abbreviated EOP is being submitted because AmeriPower currently serves no customers. AmeriPower is currently in the process of evaluating its return to the marketplace. 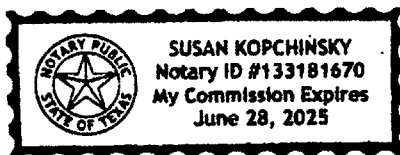
