The Emergency Operations Plan (EOP) developed to comply with the updated §25.53. Electric Service Emergency Operations Plan Rule, has been distributed to TPP Managers and key Operations personnel;

TPP Operations personnel have received training on the updated EOP;

TPP executives have reviewed the EOP;

In accordance with the updated §25.53. Electric Service Emergency Operations Plan Rule, a drill (tabletop exercise) for TPP Operations personnel was conducted in CY2022;



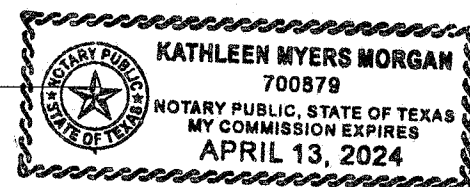


