I attest that DME's emergency management personnel who are designated to interact with local, state, and federal emergency management officials during emergency events as part of the City's Emergency Operations Center have received the latest IS-100, IS-200, IS-700, and IS-800 National Incident Management System training.
- 10. The facts stated herein are based on information and belief and are true and correct to the best of my knowledge.


