



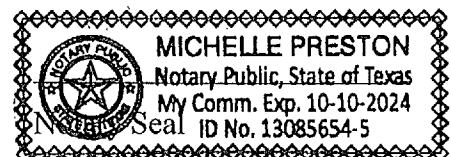

1. My name is Bill Hetherington. As Chief Executive Officer of Bandera Electric Cooperative, Inc. (BEC), I am the highest-ranking officer of BEC with binding authority over BEC. I am familiar with BEC's Emergency Operations Plan (EOP) by virtue of my duties and responsibilities.
2. All relevant operating personnel are familiar with and have received training on the contents of the EOP, and such personnel are committed to following to following the EOP except to the extent deviations are appropriate as a result of specific circumstances during the course of an emergency;
3. The EOP has been reviewed and approved by the appropriate executives;
4. Required drills have been conducted;
5. The EOP or an appropriate summary has been distributed to local jurisdictions as needed;
6. BEC maintains a business continuity plan that addresses the return to normal operations after a disruption caused by an incident; and
7. BEC's emergency management personnel who are designated to interact with local, state, and federal emergency management officials during emergency events have received National Incident Management System training ("NIMS"), specifically IS-700.a, IS-800.b, IS-100.b, and IS-200.b. In addition, BEC has adopted NIMS principles and concepts going forward.
