1. My name is Doug Turk. I am the General Manager and Chief Executive Officer for Sam Houston Electric Cooperative, Inc. I am over the age of 18 years, of sound mind, and have the legal capacity to execute this Affidavit. All matters stated in this Affidavit are true and correct and are based on my personal knowledge.

2. In the previous calendar year, Sam Houston Electric Cooperative did not make a change to its Emergency Operations Plan ("EOP") that materially affects how Sam Houston Electric Cooperative would respond to an emergency.

3. Relevant operating personnel are familiar with and are currently receiving training on the applicable contents and execution of the EOP, and such personnel are instructed to follow the applicable portions of the EOP except to the extent deviations are appropriate as a result of specific circumstances during the course of an emergency.

4. The EOP has been reviewed and approved by the appropriate executives.


5. Drills have been conducted to the extent required by subsection (f) of 16 Texas Administrative Code § 25.53.

6. The EOP or an appropriate summary has been distributed to local jurisdictions as needed.

7. Sam Houston Electric Cooperative maintains a business continuity plan that addresses returning to normal operations after disruptions caused by an incident.

8. Sam Houston Electric Cooperative's emergency management personnel who are designated to interact with local, state, and federal emergency management officials during emergency events have received the latest IS-100, IS-200, IS-700, and IS-800 National Incident Management System training.
