"I am the General Manager of Fayette Electric Cooperative, Inc. (FEC), which is a Texas electric cooperative corporation.

FEC operates an electric distribution utility system in the State of Texas and the Electric Reliability Council of Texas power region.

FEC has adopted an Emergency Operations Plan (EOP) that complies with 16 Texas Administrative Code §25.53 - Electric Service Emergency Operations Plans (EOP Rule), which was adopted by the Public Utility Commission of Texas on February 25, 2022.

FEC's relevant operating personnel are familiar with and have received training on the applicable contents and execution of the EOP, and such personnel are instructed to follow the applicable portions of the EOP except to the extent deviations are appropriate as a result of special circumstances during the course of an emergency.

The EOP has been reviewed and approved by the appropriate executives of FEC.

Drills will be conducted to the extent required by subsection (f) of the EOP Rule.

The EOP or an appropriate summary of the EOP has been distributed to local jurisdictions as needed.

FEC maintains a business continuity plan that addresses returning to normal operations after disruptions caused by an incident.

FEC's emergency management personnel who are designated to interact with local, state, and federal emergency management officials during emergency events have received the latest IS-100, IS-200, IS-700, and IS-800 National Incident Management System training."
