*“I am the City Manager for the City of Giddings (COG), which is an incorporated municipality in the State of Texas.*

*COG operates an electric distribution utility system in the State of Texas and the Electric Reliability Council of Texas power region.*

*The Emergency Operations Plan (EOP) developed to comply with the updated 16 TAC §25.53. Electric Service Emergency Operations Plan Rule, has been distributed to COG Managers and Operations personnel;*

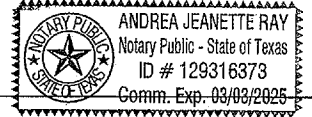


The §25.53. Electric Service Emergency Operations Plans Rule is applicable to COG.

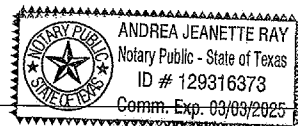


