- 1. "My name is CLIF LANGE. I am over 21 years of age, have personal knowledge of the facts surrounding the statements made herein, and am otherwise competent to put forth this testimony. The facts stated in this affidavit are within my personal knowledge and are true and correct.
- 2. I am the General Manager of SOUTH TEXAS ELECTRIC COOPERATIVE, INC. ("STEC") and the Manager of SOUTH TEXAS SOLAR POWER, LLC ("STSP") and am the highest-ranking official with binding authority over STEC and STSP, respectively, and affirm the following:
- 3. All relevant operating personnel are familiar with and have received training on portions of the Emergency Operations Plan ("EOP") applicable to assigned duties and such personnel are instructed to follow the applicable portions of the EOP to the extent that deviations are appropriate as a result of specific circumstances during the course of an emergency.
- 4. The EOP has been reviewed by appropriate executives at STEC and STSP, respectively.
- 5. STEC and STSP have conducted drills on the EOP in accordance with PUC Subst. Rule \$25.53.
- 6. A redacted version of the Hurricane Preparedness Plan has been provided to the local jurisdiction and appropriate summaries or individual annexes of the EOP have been provided to local jurisdictions as needed.
- 7. STEC's and STSP's EOP includes plans to continue business and return to normal

operations after disruptions caused by various types of incidents.

8. Personnel on staff have received certificates of completion of the latest IS-100, IS-200, IS-700 and IS-800 National Incident Management System training and are designated or will be designated to interact with local, state and federal emergency management officials during an emergency event as necessary."




