- 1. My name is Tristan Grimbert. I am President & CEO at EDF Renewables, Inc. and the highest-ranking representative, official, or officer with binding authority over Bobcat Bluff Wind Project, LLC ("Bobcat Bluff Wind"). I am over 18 years of age, of sound mind, and competent and authorized to make this affidavit on behalf of Bobcat Bluff Wind. I have personal knowledge of the matters described herein.
- 2. Bobcat Bluff Wind is registered with the Public Utility Commission of Texas as a power generation company. Bobcat Bluff Wind is a wholly owned subsidiary of EDF Renewables, Inc.
- 3. Bobcat Bluff Wind filed an emergency operations plan (the "Plan") in accordance with 16 Texas Administrative Code ("TAC") § 25.53 on April 18, 2022 and supplemented this filing on April 20, May 16, and November 10, 2022.
- 4. No changes have been made to Bobcat Bluff Wind's list of emergency contacts as provided under 16 TAC § 25.53(c)(4)(B) since Bobcat Bluff Wind's filing on April 18, 2022 (as supplemented on April 20, 2022).
- 5. No changes were made to the Plan that materially affect how Bobcat Bluff Wind would respond to an emergency.
- 6. All relevant operating personnel are familiar with and have received training on the applicable contents and execution of the Plan, and such personnel are instructed to follow the applicable portions of the Plan except to the extent deviations are appropriate as a result of specific circumstances during the course of an emergency.
- 7. The Plan has been reviewed and approved by the appropriate executives.
- 8. Bobcat Bluff Wind conducted drills on its Plan on October 14 and 28, 2022 in accordance with 16 TAC § 25.53(f).
- 9. The Plan or an appropriate summary has been distributed to local jurisdictions as needed.
- 10. Bobcat Bluff Wind maintains a business continuity plan that addresses returning to normal operations after disruptions caused by an incident.

11. Bobcat Bluff Wind emergency management personnel who are designated to interact with local, state, and federal emergency management officials during emergency events have received the latest IS-100, IS-200, IS-700, and IS-800 National Incident Management System training.
