Emergency Operation Plan Objective

Hamilton County Electric Cooperative Association (“HCEC”) maintains an emergency restoration plan in anticipation of natural and unnatural disasters or situations involving curtailments or major interruptions in electrical service. The plan sets forth organizational and personnel assignments, describes emergency communications procedures and lists emergency contacts.

HCEC will conduct a disaster drill annually, whether it is table top, simulated or a review of a disaster event.

The engineering department of HCEC, located at our main building at 420 North Rice St. in Hamilton, TX, is responsible for maintaining the Emergency Operation Plan.

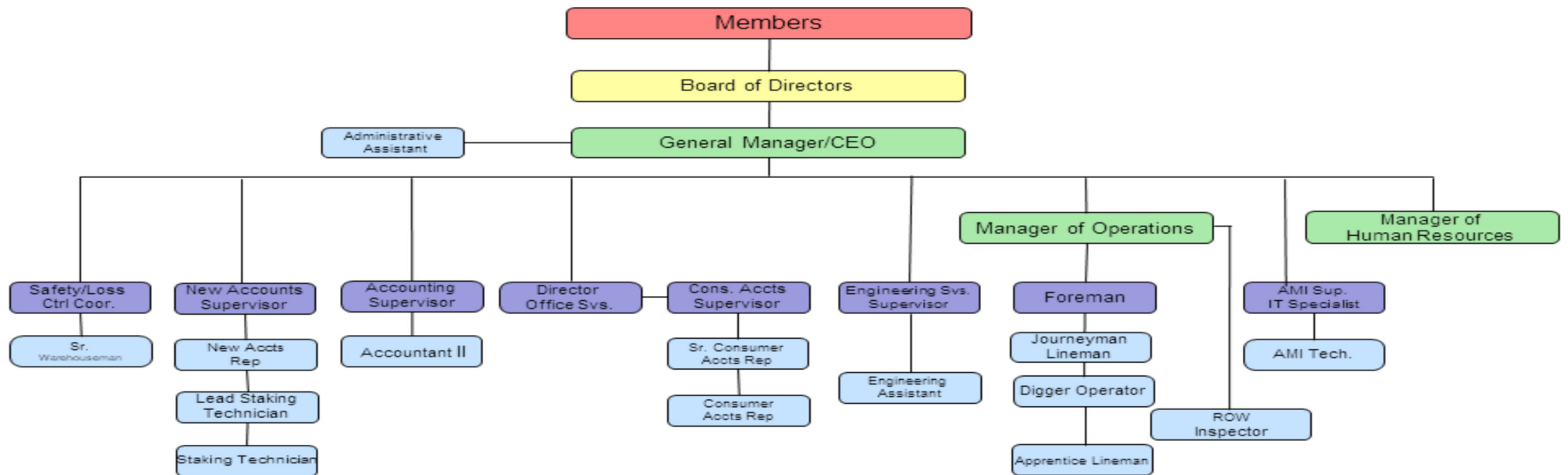

Organizational and Personnel Responsibilities

During an Emergency

I. Situation Assessment

The General Manager is responsible for monitoring threats to the reliability of the system and for assessing damages. He will determine if outside assistance is required. The General Manager or other HCEC personnel may use the problem resolution diagram, located on page 7, to assist in an emergency for determining which issues have the highest priority.

II. Incoming Calls

The Service Department is responsible for managing incoming telephone calls reporting outages and for receiving outage reports from members. Office personnel may be assigned to telephone or front office duty as required.

III. Dispatching/Communications

The Manager of Operations or his designee will handle dispatching. The Manager of Operations is also responsible for maintenance of additional radios and other communications equipment for use during an emergency.

IV. Reporting

The General Manager or his designee is responsible for reporting emergency information to the Public Utility Commission of Texas, HCEC's power supplier, and local government emergency operations centers. All contacts with local new media will be handled by a representative from Nitcher Group, our insurance provider.

V. Securing Repair and Reconstruction Assistance

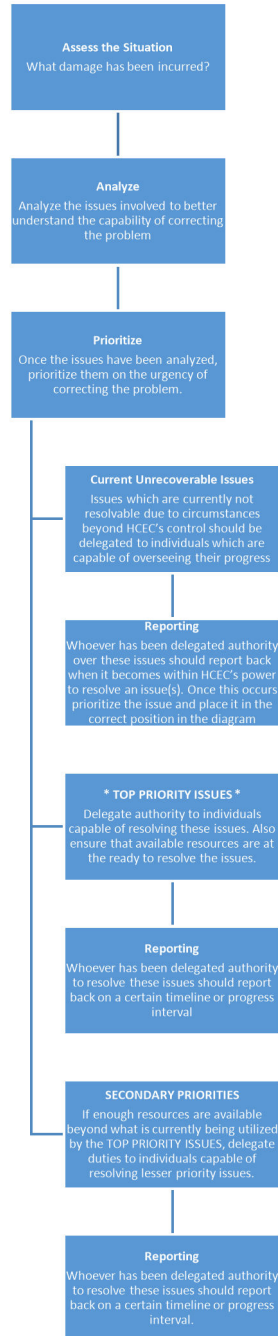
The General Manager or his designee is responsible for contacting other cooperatives, Texas Electric Cooperatives ("TEC"), or any other outside entities to request emergency assistance.

Critical Accounts Setup and Contact Procedure

Critical Accounts – Location(s) of List

- The “critical” accounts listing for consumers are maintained in HCEC’s billing system.
- There is also a copy maintained in another electronic form in the “Emergency Response Plan” folder on the network drive.

Critical Accounts – Adding Accounts to Registry

- Once HCEC has been notified that there is a reason to list a location as a “critical” account, HCEC adds a note to the consumers account. A list of these accounts is available from the billing system by running the “Outage Priority Listing” report in iVUE.

Critical Accounts – Communicating with Critical Accounts during Prolonged Outages

- If HCEC encounters an extended outage situation, all reasonable efforts will be made to contact “critical” accounts in the affected area. If we are able to contact the member, we will relay the estimated time of the outage if known. If we are unable to contact the member, we will dispatch a service man or men to the location or locations of the critical care customers.

Critical Accounts – Staff / Dispatcher Training

- All staff / dispatchers are aware that they need to make note of any critical care customers that call in during an outage. All reasonable efforts are made to contact service personnel in the area so they know that this location is a priority for restoration or may require assistance.

HCEC Communications Plan

Communications – Contacting Media (TV, Radio, Newspaper)

- During an extended outage period, the Nitcher Group, our insurance provider, will be responsible for contacting the various media outlets that serve our service area. They will be responsible for conveying the following information to the various media outlets:
 - The reason for the outage.
 - The extent of our service area affected by the outage.
 - The estimated time of recovery for the affected area.

Communications – Telephone System

- HCEC's telephone system is manned by cooperative personnel during normal business hours. HCEC personnel are instructed to activate forwarding of all received calls to dispatchers for after hours and weekend calls.

Communications – Critical Accounts (Consumer & Commercial/Business Customers)

- Critical consumer accounts will be handled according to the Critical Accounts Setup and Contact Procedures.
- Most critical commercial accounts already have some sort of monitoring system in place for unmanned locations. HCEC will make all reasonable efforts to inform critical commercial customers as to the cause of the outage and the estimated recovery time.

Communications – Complaints by Consumers & Commercial/Business Customers

- All personnel working with consumers on the extended outage will be informed by the service department, engineering, or Manager of Operations as to the nature of the outage and when to expect restoration of service. If the consumer is not satisfied with the response, the call will be redirected to the member service representative or management.

Planned Outages, Load Shedding and Restoration Priorities

Planned Outages

- HCEC will notify members via letter of planned outages scheduled in an area. The letter will inform the members of the date and the approximate time of the start of the planned outage and the expected duration of the outage. If there are any critical accounts (consumer or business) these members are also contacted via telephone before the outage.

Load Shedding

- If a supply grid overload occurs Brazos Electric Power Cooperative, Inc. will inform HCEC via phone and e-mail message that it is necessary to begin load shedding procedures. LCRA will inform HCEC via phone, text message or email that it is necessary to begin load shedding procedures.
- The Manager of Operations or engineer will either perform the load shedding procedure themselves or instruct service personnel. Cooperative personnel answering phones will be made aware of the situation as soon as possible.

Restoration Priority

- Outage restoration priority will be based on the following items:
 - Availability of personnel and material to restore system operation.
 - Priority critical consumer accounts without power.
 - Priority business/infrastructure accounts without power.
 - Location of crews in service area.
 - Extent of outage affecting HCEC's distribution system.

State Operations Center (SOC) Declared Event or Inquiry

- During a "SOC" declared event or inquiry the Cooperative shall provide updates on the status of operations, outages, and restoration efforts. Updates shall continue until all event-related outages are restored or until notified by commission staff that reporting by the Cooperative is no longer required.

Pandemic Mitigation Guidelines

1. Pandemic is Declared

- Management and Supervisors meet to discuss plan of action

2. Employee Education & Awareness

- Inform employees about how to prevent spreading the disease. Encourage employees to get vaccinated yearly for influenza and pneumonia.
- Place posters and send out e-mails to reinforce preventing spreading the disease from the CDC and other reputable sources.
- Inform employees to keep physical contact to a bare minimum or not at all. Building personnel will isolate to their own building. Crews and servicemen will also isolate from each other.
- Inform employees who are sick to stay home. If employees may have been exposed management will inform the employees and send them home for the required time to determine if they develop symptoms. Employees will communicate with their supervisor if they experience any symptoms.
- Consider taking temperature of employees and vendors as they enter the building.

3. Keeping Workspace Environment Clean

- Make sure that enough supplies of hand sanitizer and disinfecting wipes are on hand.
- Clean and disinfect touch points such as doorknobs, counters, light switches.
- Execute deep cleaning in any areas where an infected employee has been.

4. Members and Vendor contact

- Close main lobby to limit contact between Members and employees.
- Limit the number of nonessential visitors.
- Inquire the health status from any visitors that might access the building as to if they are having symptoms of the disease.

5. Work-From-Home and Meetings

- Use teleconferencing/videoconferencing as to in person meetings.
- Discontinue nonessential travel for meetings/events. Inquire if an employee has been to an affected area recently.

- Work-from-home will be at the discretion of management based on job function.

6. Workplace Continuity

- Use staggered work schedules as needed. This includes picking up material for crews and servicemen from the warehouses.
- Workplace duties may need to be reassigned/distributed if an employee becomes sick or is absent and cannot perform their job function.

Severe Weather and Wildfire Guidelines

General Actions

This section of HCEC's EOP will describe the general actions that HCEC will take to ensure that it identifies potentially significant cold or hot weather events. This will also include making sure that adequate staffing and materials are available should the situation require it. The Cooperative will make every effort to make sure that it has completed this in advance of an approaching event through proactive planning so that it can deal with the operating challenges and initial response to any event in an efficient manner.

Identification and Communication of Severe Weather Events

HCEC's Manager of Operations keeps track of weather events that can affect the Cooperative via messages sent from ERCOT, Brazos, LCRA, and various other weather services (NWS, Local TV stations).

These alerts allow for an early identification of weather events that could be of significant to the Cooperative for emergency planning in the event this Emergency Operation Plan (EOP) needs to be implemented. The decision to implement the EOP will be based on the conditions or combinations of conditions that may threaten the Cooperative ability to provide electric service to its members. The methods used for identification and communicating of severe weather events will be as follows:

1. HCEC's Manager of Operations shall inform Cooperative personnel of impending severe weather affecting the Cooperatives service area.
2. HCEC's Manager of Operations shall evaluate the available weather information and decide if the implementation of the EOP is justified for the situation. The following guidelines will be used to help determine this implementation:
 - An event wither it be by environmental or weather that is judged to pose a threat to HCEC's distribution system
 - Severe weather such as lightning storms, thunderstorms, tornados, or ice/snow with/or high winds and flooding that have the potential to impact a large portion of HCECs service area.
 - Hot weather conditions that are estimated to remain over an extended period of time with temperatures remaining above 103F which can effect components on HCEC's distribution

system. The main concerns in this condition(s) are forced outages due to equipment failures and/or overloading or rolling blackouts mandated by our power supplier, ECT.

- Wildfire and/or drought conditions in HCEC's service area that could affect the system such as insulators coated in dust, evacuations due to water shortages in portions of the Cooperative's service area, ECT.
- Cold weather conditions that are estimated to remain over an extended period of time with temperatures remaining below 20F in addition to wind chill which can effect components on HCEC's distribution system. The main concerns in this condition(s) are galloping conductors, freezing on Cooperative distribution equipment, and rolling blackouts mandated by out power supplier, ECT.

3. HCEC will assemble all available supervisors and other required personnel to implement the activation of the Server Weather and Wildfire Guidelines portion of the EOP. This will include preparation for the event and deciding on responses to the actions outlined as follows:

- The activation of the EOP will be communicated to appropriate personnel via phone, text, or e-mail. This will serve to raise the level of awareness and the need start preparation for a potential imminent event which will impact the operations of the Cooperative.
- Cooperative personnel will either prepare a potential list of responses or go off of responses covered in one of the Cooperatives disaster drills which may have impact on the current situation. All personal that will be required to deal with the event will be called into service. Supervisors and management will meet to discuss the most effective strategies and courses of action to deal with the impending situation(s).
- Should the need arise Cooperative management will be in contact with neighboring electrical distribution and/or transmission providers concerning coordinating a response to the impending situation(s). Cooperative personnel will conduct themselves in a professional manner when dealing with personnel from other electrical distribution and/or transmission providers.
- Cooperative personnel will strive to maintain situational awareness at all times during the duration of the event. Making sure key personnel are provided with the planned response actions and assigning personnel to be points-of-contact for coordination of the response actions.
- Cooperative personnel will also determine when the event conditions are past and Cooperative operations can return to normal, this may also involve communications with Brazos Electric and LCRA depending on the conditions the Cooperative had. The Cooperative will then conduct an after event meeting to assess the Cooperatives response to the event and look for ways to improve the Cooperatives response and/or

procedures for future events that may occur. Any policies or procedures that need to be updated or changed should be noted and action takes to update these as required.

Should the Cooperative have the need to communicate with the Public the Cooperative will use the communications guidelines laid out in the HCEC's Communications Plan portion of the EOP. As of 5/27/2015 Cooperative personnel that have been designated for contact with our members or who will interact with local, state, or federal emergency management officials have not currently received Federal Emergency Management Agency (FEMA) National Incident Management Systems (NIMS) training, specifically IS-700.a, IS-800.b, IS-100.b, IS-200.b training. This will be rectified in the near future.

4. Severe Storms

The following is a list of potential actions that may be implemented for severe storm threats such as thunderstorms, intense lightning storms, tornados, ice and show accompanied with high winds, or flooding conditions:

- a. Cancel any current maintenance activities on the Cooperative's system unless such maintenance will help with the current weather situation.
- b. Notify all Cooperative personnel to prepare for extended working hours should the need arise.
- c. If determination of effected areas can be determined early enough, send personnel to the area to be effected before the storms impacts the service in these areas.
- d. If a tornado is reported in an area make sure personnel have gotten sufficient materials to deal with the damage of downed lines and poles.
- e. Ensure the generator at the Cooperative's main office is filled with fuel incase the offices loose power for an extended period.

5. Severely Cold Weather

The following is a list of potential actions that may be implemented for potentially severe cold weather conditions:

- a. Make sure there is sufficient personal available to make it into the office for answering phones and performing repair to the Cooperative's distribution system.

- b. Notify all Cooperative personnel to prepare for extended working hours should the need arise.
- c. Cancel any current maintenance activities on the Cooperative's system unless such maintenance will help with the current weather situation.
- d. Cancel any maintenance on computer or phone systems unless such maintenance is critical to keeping the Cooperative's ability to communicate with consumers and other entities.
- e. Prepare for the implementation of other emergency procedures.

6. Severely Hot Weather

The following is a list of potential actions that may be implemented for potential severe, hot weather conditions:

- a. Make sure there is sufficient personnel available to make it into the office for answering phones and performing repair to the Cooperatives' distribution system.
- b. Cancel any current maintenance activities on the Cooperative's system unless such maintenance will help with the current weather situation.
- c. Cancel any maintenance on computer or phone systems unless such maintenance is critical to keeping the Cooperative's ability to communicate with consumers and other entities.
- d. Prepare for the implementation of other emergency procedures.

7. Drought and Wildfire Threats

The following is a list of potential actions that may be implemented for drought and related wildfire conditions:

- a. Monitor Nations Weather Service (NWS) or other agencies for Red Flag Warnings. Identify any Cooperative equipment or facilities that may be impacted in the Wildfire threat area. Concerns include water shortages, threatened distribution equipment, contamination of insulators.
- b. Notify all personnel to prepare for possible extended working hours and placing crews close the areas that might be effected. Check all trucks and make sure there is a fuel card available for use and if not get a spare card.

- c. Determine if any OCRs or other equipment need to be opened up to minimize impact to the Cooperative's system by isolation of the affected area from the distribution system.
- d. Prepare for crews and office personnel to be on-site for extended periods by making sure that essential items such as water, food, personal hygiene items, etc. are available. Make sure that arrangements have been made with local restaurants for outside personal in the field to get meals easily.

Procedure for Acquiring Replacement Materials during a Disaster Situation

- The Manager of Operations will assess the damage to the system and the available material on hand in our warehouse.
- The Manager of Operations will then inform the Warehouse Supervisor of the estimated quantities of materials required to restore the distribution system to full operation.
- The Warehouse Supervisor will then provide the estimated delivery time given by the supplier to the Manager of Operations.
- The Cooperatives material inventory is now managed by Texas Electric Cooperatives (TEC). We have been assured by TEC that getting adequate materials during an event will not be an issues because they maintain a reserve at their warehouse in Georgetown, TX just for situations outlined in the previous section.
