- 1. My name is Alicia Hooks. I am over the age of 18 years and am competent to make this Affidavit and the facts I state are true and correct.
- 2. I am the General Manager of the Greenville Electric Utility System, now known as "GEUS," and have served in that capacity since 2018. My business physical address:

All relevant operating personnel are familiar with and has received the EOP and such personnel are instructed to follow the applicable contents and execution of the EOP and such personnel are instructed to follow the applicable portions of the EOP except to the extent deviations are appropriate as a result of specific circumstances during the course of any emergency.
- 4. The EOP has been reviewed and approved by the appropriate executives.
- 5. Drills have been conducted to the extent required by subsection 16 TAC § 25.53 (f). GEUS' will not be conducting or participating in a drill in the year 2023 due to the activation of GEUS' Emergency Operations Plan for pandemic purposes and weather emergencies.
- 6. The EOP, or an appropriate summary, has been distributed to local jurisdictions as needed.
- 7. GEUS maintains a business continuity plan that addresses returning to normal operations after disruptions caused by an incident.
- 8. GEUS' emergency management personnel who are designated to interact with local, state and federal emergency management officials during an emergency event has received the latest IS-100, IS-200, IS-700 and IS-800 National Incident Management System training.
