- 7. Blue Cube maintains a business continuity plan that addresses returning to normal operations after disruptions caused by an incident.

8. Blue Cube's emergency management personnel who are designated to interact with local, state, and federal emergency management officials during emergency events have received the latest IS-100, IS-200, IS-700, and IS-800 National Incident Management System ("NIMS") training.
