I do not feel this new rate charge is appropriate. Our water bill and surcharges are high enough without this additional charges. Also if this has to do with your freeze last winter when we were out of water for ten days, I do not feel I should have to pay for your neglect or repairs to the pumps or to upkeep them. Isn't that what our normal charges go to which you keep raising. Your service covers very little and we are already responsible for all our lines on our property which in itself can cost us a pretty penny. And in the midst of a financial depression you want to add to the burdens of survival. I am sure you mayor company owners are not suffering, but if they would upkeep equipment instead of just letting it go, I feel these charges would not have been brought up.
