With the recent increase in cost to living that our region has suffered, the inability for homeowners to have a choice in their water provider is very detrimental. After speaking to others in surrounding neighborhoods (notably the Audobon Community), it has come to my attention that we (Atascocita Springs) are already paying three times as much for water.
