I am requesting to be a commenter on PUC Docket No. 53428.

With the recent increase in cost to living that our region has suffered, the inability for homeowners to have a choice in their water provider is very detrimental. After speaking to others in surrounding neighborhoods (notably the Audobon Community), it has come to my attention that we (Atascocita Springs) are already paying three times as much for water. I have spoken to many people in and around the Houston/Humble area that are shocked when they hear the amount that we are already paying for water. Unfortunately we have no other option but to use Aqua Texas as our provider. The cost that we are paying has and continues to be a detriment to our financial resources.
