JOINT RESPONSE TO ORDER NO. 8

COME NOW CSWR-Texas Utility Operating Company, LLC (“CSWR Texas”) and Water Works I and II (“Water Works”), together with the Staff of the Public Utility Commission of Texas (“Commission Staff”) (collectively, “the Parties”), and file this Joint Response to Order No. 8.

Order No. 8 directs CSWR Texas and Commission Staff to clarify whether they conferred with Mark Blankenship, the only intervenor in this docket. Both CSWR Texas and Commission Staff reached out to counsel for Mr. Blankenship regarding Order No. 8, but received no substantive response. On August 23, 2022, Mark Blankenship withdrew his request to intervene. Therefore, CSWR Texas and Commission Staff contend that Order No. 8 is now moot and respectfully request that the Administrative Law Judge issue an order granting the Joint Motion to Admit Evidence.
