COMMISSION STAFF’S UNOPPOSED REQUEST FOR AN EXTENSION

On February 22, 2022, CSWR-Texas Utility Operating Company, LLC (CSWR-Texas) and Cody and Anita Lewis dba Cassie Water Company, Deer Springs Water Company, and Water Works I and II filed an application for approval of the sale, transfer, or merger of facilities and certificate of convenience and necessity rights in Burnett and Llano counties. On March 29, 2022, Staff (Staff) of the Public Utility Commission requested that Docket No. 53259 be severed into three separate dockets, one for each system. On April 4, 2022, the administrative law judge (ALJ) filed Order No. 1, severing the proceedings, and restyling this docket to include only CSWR-Texas and Water Works I and II (collectively, Applicants).

On February 7, 2024, the ALJ filed Order No. 18, directing the parties to jointly file a proposed notice of approval, including findings of fact, conclusions of law, and ordering paragraphs by April 3, 2024. Therefore, this pleading is timely filed.

I. UNOPPOSED REQUEST FOR AN EXTENSION

Pursuant to 16 Texas Administrative Code § 22.4(b), a party may request that the time allowed for the filing of any documents be extended for good cause. Staff requires additional time to complete drafting a proposed notice of approval with the Applicants. The Applicants have indicated that they are unopposed to Staff’s extension request. Accordingly, Staff respectfully requests an extension of time to April 5, 2024, for the parties to jointly file a proposed notice of approval.

II. CONCLUSION

Staff respectfully requests the entry of an order extending the parties’ deadline to jointly file a proposed notice of approval to April 5, 2024.
