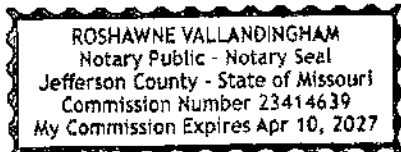

**CSWR-TEXAS UTILITY OPERATING COMPANY, LLC'S
STATEMENT OF CONFIDENTIALITY**

Pursuant to the Commission's standard protective order, CSWR-Texas Utility Operating Company, LLC ("CSWR-Texas") is designating certain materials filed as part of its capital improvements plan as Protected Materials. The undersigned counsel for CSWR-Texas has reviewed the information sufficiently to state in good faith that the information is exempt from public disclosure under the Public Information Act and merits the Protected Materials designation or Highly Sensitive Protected Material designation given below.

The confidential capital improvement plan maps filed on April 30, 2024 contains proprietary information of a third-party engineering firm. Public disclosure of the information would cause substantial competitive harm to the engineering firm by allowing other engineering companies to copy the firm's methods and analyses. Public disclosure could also negatively impact the engineering firm's willingness to perform services for CSWR-Texas in the future. Accordingly, the information contained therein is exempt from public disclosure under Tex. Gov't Code §§ 552.101.
