Staff 2-1 In response to Staff RFI 1-1, Undine Texas LLC provided a copy of the water treatment plant approval letter. This letter does not appear to approve the distribution system. The letters approving the distribution system will indicate a specific number of linear feet and size of the piping to be installed. For example:

“The submittal consisted of 22 sheets of engineering drawings and technical specifications. The approved project consists of:

- 27,300 linear feet of 6-inch, American Water Works Association Standard C900, Dimension Ratio 18, polyvinyl chloride pipe; and,
- Various valves, fittings, and appurtenances.”

Please provide a copy of the Texas Commission on Environmental Quality approval letter for the distribution system that will provide water service to the Tejas Lakes Subdivision.
