**COMMISSION STAFF’S THIRD REQUEST FOR EXTENSION**

On April 1, 2022, Undine Texas LLC (Undine) filed an application to amend its Certificate of Convenience and Necessity (CCN) in Fort Bend County. Undine holds water CCN No. 13260. The requested service area consists of 90 acres and 0 existing connections. Undine filed supplemental information on April 4, 2022, September 12, 2022, September 14, 2022, and September 21, 2022.

On September 13, 2022, the administrative law judge (ALJ) filed Order No. 5, establishing a deadline of October 4, 2022, for the Staff (Staff) of the Public Utility Commission of Texas (Commission) and Undine (collectively, Parties) to file joint proposed findings of fact, including findings that address the factors in Texas Water Code 13.246(c), and conclusions of law. Therefore, this pleading is timely filed.

**I. REQUEST FOR EXTENSION**

Under 16 TAC § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff needs additional time to prepare the joint proposed findings of fact and conclusions of law. As such, Staff respectfully requests an extension of its deadline until November 4, 2022.

**II. CONCLUSION**

For the reasons detailed above, Staff respectfully requests the entry of an order extending Staff’s deadline to November 4, 2022, to file joint proposed findings of fact and conclusions of law.
