COMMISSION STAFF’S REQUEST FOR EXTENSION

I. INTRODUCTION

On April 1, 2022, Undine Texas LLC (Undine) filed an application to amend its Certificate of Convenience and Necessity (CCN) in Fort Bend County. Undine holds water CCN No. 13260.

On January 20, 2022, the administrative law judge (ALJ) filed Order No. 9, establishing a deadline of January 30, 2023 for the Staff (Staff) of the Public Utility Commission of Texas (Commission) to clarify several details of its final recommendation. Therefore, this pleading is timely filed.

II. REQUEST FOR EXTENSION

Under 16 TAC § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff needs additional time to confirm that the issues raised by the Commission in its order on remand in Docket No. 52391¹ have been addressed. As such, Staff respectfully requests an extension of its deadline until February 13, 2023. Staff attempted to confer with counsel for Undine regarding the extension, but was unsuccessful.

III. CONCLUSION

For the reasons detailed above, Staff respectfully requests the entry of an order extending Staff’s deadline to February 13, 2023, to file the clarifications requested in Order No. 8.
