SUPPLEMENTAL MOTION TO ADMIT EVIDENCE AND CLARIFICATION

I. BACKGROUND

On November 4, 2022, Staff (Staff) of the Public Utility Commission (Commission) and Undine Texas LLC (Undine) (collectively, Parties) filed their Joint Motion to Admit Evidence pursuant to Order No. 6. April 28, 2023, the Administrative Law Judge (ALJ) filed Order No. 13, requiring Parties file a supplemental motion to admit evidence on or before May 5, 2023 regarding the inclusion of supplemental information filed by Undine on January 20, 2023 and January 24, 2023. Therefore, this pleading is timely filed.

II. SUPPLEMENTAL MOTION TO ADMIT EVIDENCE

Parties move to admit following as supplemental evidence into the record of evidence in this proceeding:

- 1) Applicant's supplemental information, filed on January 20, 2023 (AIS Item Nos. 39 and 40); and

Additionally, confidential attachment EB-1 was admitted into the record in Order No. 12, bullet (10) – Commission Staff's final recommendation on the application and *confidential attachment*, filed September 19, 2022. The confidential attachment referenced in (10) is confidential attachment EB-1.
