ORDER CANVASSING ELECTION RETURNS FOR MAXWELL SPECIAL UTILITY DISTRICT CONFIRMATION AND DIRECTORS ELECTION

WHEREAS, The Texas Legislature created Maxwell Special Utility District (the "**District**"), located in Hays and Caldwell Counties, Texas, pursuant to S.B. 1422, an Act of May 25, 2019, 86th Leg., R.S., ch. 559, 2019 Tex. Gen. Laws (codified at Ch. 7222, Special District Local Laws Code) (the "**Enabling Statute**"), with the purposes, powers, and boundaries described therein; and

WHEREAS, the metes and bounds description of the boundaries of the District, attached hereto as Exhibit "A", as included in the Enabling Statute, reflect approximately the same boundaries described in the attached property description; and

WHEREAS, in conformance with Section 7222.0151 of the Enabling Statute, the temporary directors, who collectively constitute the District's temporary Board of Directors, have met, organized, and qualified to serve as directors of the District by taking the oath and making the bond required by law; and

WHEREAS, under subsection 7222.0152(a) of the Enabling Statute, the Board must, before September 1, 2022, call and hold an election to confirm the creation of the District and to elect nine initial directors, in accordance with Chapters 49 and 65 of the Texas Water Code; and

WHEREAS, the Board of Directors of the District ordered a Confirmation and Directors Election to be held in the District on January 23, 2020 (the "Election Order"); and

WHEREAS, the Board of Directors has investigated all matters pertaining to the election, including the calling of the election, giving of notice, appointment of officers, holding of the election, and making returns of the election; and

WHEREAS, the election officers who held the election have duly made the returns of the results thereof, and the returns have been duly delivered to this Board of Directors.

NOW THEREFORE, BE IT ORDERED BY THE BOARD OF DIRECTORS OF MAXWELL SPECIAL UTILITY DISTRICT:

Section 1. The Board of Directors finds the preceding recitals to be true and accurate legislative findings of fact.

Section 2. The Board of Directors officially finds and determines that said election was duly ordered, that proper notice of said election was duly given, that proper election officers were duly appointed prior to said election, that said election was duly held, that due returns of the result of said election have been made and delivered to the Board of Directors of the District and duly filed with the Secretary of the Board of Directors, and that the Board of Directors has duly canvassed said returns, all in accordance with the law and the Election Order.

<u>Section 3</u>. The Board of Directors officially finds and determines that the following votes were cast by resident, qualified electors of the District who voted at the election, with regard to the proposition on the Ballot:

PROPOSITION A SHALL THE CREATION OF MAXWELL SPECIAL UTILITY DISTRICT BE CONFIRMED

Section 5. The Board of Directors officially finds, determines, and declares the result of the Confirmation Election described in Proposition A to be that the highest number of votes was cast in favor of confirmation of the District and that the District with the boundaries described by meets and bounds in Exhibit "A" hereto, which is hereby incorporated herein for all purposes, is duly confirmed by the qualified electors of the District.

Section 6. The Board of Directors officially finds, determines, and declares that the Directors Election has resulted in the election of the following nine permanent directors for the District: Doug Spillman, Valentine R. Yanez, Jr., Sarah DeShay, Liralen Canion, Robert Karasch, Brian Freeman, Mabel Vaughn, Nadine Hodges, and Doris L. Steubing. Pursuant to

Section 49.102 of the Texas Water Code, the directors who were elected have agreed that they shall designate their respective initial terms of office as follows:
