ORDER NO. 4 FINDING NOTICE SUFFICIENT AND ESTABLISHING A PROCEDURAL SCHEDULE

This Order addresses the sufficiency of notice of the application of Monarch Utilities I L.P. to amend its water certificate of convenience and necessity (CCN) number 12983 in Johnson County and for partial decertification of Johnson County Special Utility District's CCN number 10081 and Mountain Peak Special Utility District's CCN number 10908. On August 1, 2022, Commission Staff filed a recommendation on the sufficiency of notice.

On July 21, 2022, the petitioners filed the affidavit of George Freitag, regulatory manager for Monarch, attesting that notice of the application was provided to current customers and affected entities on July 11, 2022. Further, a confidential list of each customer and landowner in the subject area was included with the petitioners' July 21, 2022 filing. Additionally, the July 21, 2022 filing included the publisher's affidavit of Becky Dahn, major account sales manager of the *Cleburne Times Review*, attesting to the publication of notice on July 2 and July 9, 2022.

The administrative law judge finds the notice sufficient and establishes the following procedural schedule for continued processing of this docket:
