### COMMISSION STAFF'S REQUEST FOR EXTENSION

On April 13, 2022, Leslie McFarland and Billy Grantham (Appellants) filed an appeal of the cost of obtaining service from Parker Water Supply Corporation (Parker WSC) under Texas Water Code (TWC) § 13.043(g) and 16 Texas Administrative Code (TAC) § 24.101(g).

On May 19, 2022, the administrative law judge (ALJ) filed Order No. 2, requiring the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file its final recommendation on the appeal or to request a hearing June 16, 2022. Therefore, this pleading is timely filed.

## I. REQUEST FOR EXTENSION

Under 16 Texas Administrative Code (TAC) § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff submitted a second request for information to Parker WSC on June 14, 2022. Parker WSC has 20 days to respond to Staff's second request for information. After those responses are submitted, Staff will require time to review the response and formulate a final recommendation or request for a hearing. Therefore, Staff respectfully requests the entry of an order extending the deadline for Staff to file its final recommendation on the appeal or to request a hearing to July 14, 2022.

#### II. CONCLUSION

For the reasons discussed above, Staff respectfully recommends that the procedural schedule be revised as provided above.
