COMMISSION STAFF'S REQUEST FOR EXTENSION

On April 13, 2022, Leslie McFarland and Billy Grantham (Appellants) filed an appeal of the cost of obtaining service from Parker Water Supply Corporation (Parker WSC) under Texas Water Code (TWC) § 13.043(g) and 16 Texas Administrative Code (TAC) § 24.101(g).

On June 17, 2022, the administrative law judge (ALJ) filed Order No. 3, establishing a deadline for the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a final recommendation on the appeal or to request a hearing by of July 14, 2022. Therefore, this pleading is timely filed.

I. REQUEST FOR EXTENSION

In accordance with 16 Texas Administrative Code (TAC) § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff has filed a third request for information (RFI) to Parker WSC. Staff requires the responsive information to prepare a final recommendation. To allow time for both Parker WSC to respond to Staff's third RFI and for Staff to review Parker WSC's responses, Staff respectfully requests that the deadline for Staff's final recommendation on the appeal or to request a hearing be extended to August 22, 2022.

II. CONCLUSION

Staff respectfully requests an issuance of an order extending the deadline to file its final recommendation on the appeal or to request a hearing until August 22, 2022.
