COMMISSION STAFF'S REPONSE TO ORDER NO. 1: LIST OF WITNESSES AND EXHIBITS

On April 18, 2022, the Staff (Commission Staff) of the Public Utility Commission of Texas (Commission) filed a request for an emergency order appointing Intermediary Solutions Holdings, LLC (Intermediary) as temporary manager of Smith Management Services (SMS). On April 19, 2022, the executive director of the Commission entered an emergency order granting Commission Staff's request and set a date for a hearing to affirm, modify, or set aside the emergency order for May 12, 2022. On April 20, 2022, the administrative law judge filed Order No. 1, requiring the parties to file by April 27, 2022 a list of witnesses that may be called at the hearing and copies of exhibits that will be offered into evidence at the hearing. Therefore, this pleading is timely filed.

Commission Staff may call Nima Momtahan, Receivership Coordinator in the Commission's Division of Utility Outreach, as a witness at the hearing. Commission Staff also reserves the right to call witnesses not listed herein for rebuttal or impeachment purposes.

Commission Staff offers the attached affidavit of Rose Ramirez, Legal Assistant in the Commission's Division of Compliance and Enforcement, as evidence of service. Her affidavit states that she mailed a copy of Commission Staff's Request for an Emergency Order Appointing a Temporary Manager for Marion J. Smith dba Smith Management Services Without a Hearing (Commission Staff's Request) to SMS and Intermediary on April 19, 2022. Her affidavit also states that she mailed a copy of Commission Staff's Notice of Hearing to SMS and Intermediary on April 25, 2022. Her affidavit also states that she mailed a copy of Commission Staff's Notice of Issuance of an Emergency Order Appointing a Temporary Manager to Marion J. Smith dba Smith Management Services on April 26, 2022. Attached to her affidavit is a copy of Commission Staff's Request and Notice of Hearing, as well as the relevant mailing receipts. This affidavit is designed

to prove that notice was provided consistent with Commission rules. Commission Staff has attached a copy of this affidavit to this pleading, pre-marked as **Staff Exhibit One**.

Commission Staff also offers the attached affidavit of Nima Momtahan, Receivership Coordinator in the Commission's Division of Utility Outreach, as testimony.² His affidavit provides the factual background of the matter, indicating that SMS is, in fact, abandoned. Specifically, Mr. Momtahan's affidavit speaks to SMS' failure to pay a bill to an electric utility with the result of discontinuance of service, failure to provide appropriate water treatment so that a potential health hazard results, failure to provide customers adequate notice of a health hazard or potential health hazard, failure to secure an alternative available water supply during an outage, and repeated failure to respond to the utility's customers, providing the basis for claims of abandonment under 16 TAC §§ 24.355(c)(1), (c)(2), (c)(4), (c)(5), and (c)(6) respectively. Attached to his affidavit are relevant documents and filings with the TCEQ. Commission Staff has attached a copy of this affidavit to this pleading, pre-marked as **Staff Exhibit Two**.

Commission Staff respectfully requests that Staff Exhibits One through Two, including all attachments, be admitted into evidence.

COMMISSION STAFF'S REQUEST FOR AN EMERGENCY ORDER APPOINTING A TEMPORARY MANAGER FOR MARION J. SMITH DBA SMITH MANAGEMENT SERVICES WITHOUT A HEARING

For the reasons discussed below, Commission Staff requests that the executive director of the Public Utility Commission of Texas issue an emergency order appointing Intermediary Solutions Holdings, LLC to temporarily manage and operate Marion J. Smith dba Smith Management Services. The executive director should issue this emergency order and set a time for a hearing that is as soon after the issuance of the emergency order as practicable. In support of this request, Commission Staff respectfully shows the following:

I. JURISDICTION AND LEGAL AUTHORITY

Under Texas Water Code (TWC) § 13.4132(a) and 16 Texas Administrative Code (TAC) § 24.355(a)(1), the Commission may appoint a willing person to temporarily manage and operate a utility if the utility has abandoned operations. Under 16 TAC § 24.355(c), actions constituting abandonment can include, but are not limited to, a utility's "failure to adequately maintain facilities or provide sufficient facilities resulting in potential health hazards, extended outages, or repeated service interruptions;" a utility's "failure to secure an alternative available water supply during an outage;" or a utility "repeatedly failing to respond to the commission or the utility's customers." Under TWC § 13.4132(b) and 16 TAC § 24.357(a), the Commission may appoint a temporary manager by emergency order.

A person appointed as temporary manager under TWC § 13.4132(c) and 16 TAC § 24.357(b) has the powers and duties necessary to ensure the continued operation of the utility

and the provision of continuous and adequate services to customers. One such duty requires a temporary manager to post financial assurance with the Commission, unless the temporary manager or the Commission's executive director asks for a waiver of the financial assurance or requests substitution of another means of collateral.⁴ Within 60 days of appointment, a temporary manager must make and return to the Commission an inventory of all property received.⁵ Compensation for the temporary manager comes from the utility revenues and is set by the Commission at the time of appointment.⁶ The temporary manager must collect the assets and carry on the business of the utility and use the revenues and assets of the utility in the best interests of the customers to ensure the provision of continuous and adequate service.⁷ The temporary manager is required to report to the Commission on a monthly basis the following items: an income statement for the reporting period; a summary of utility activities, such as improvements or repairs made, number of connections added, and the amount of water produced or treated; as well as any other information required by the Commission.⁸

The Commission has the authority to appoint a temporary manager by emergency order without notice or an opportunity for a hearing. Under TWC § 13.451(b), the Commission may delegate to the Commission's executive director the authority to issue emergency orders under Subchapter K-1 of the TWC, and the Commission did delegate such authority in an order issued on December 4, 2015, in Project No. 43517. Notice required under the Administrative Procedures Act¹⁰ does not apply to an emergency order issued under Subchapter K-1 of the TWC. However, 16 TAC § 22.293(c) requires the Commission to provide notice to the affected utility "as soon as practicable," and, under 16 TAC § 22.297(d)(2), the Commission or executive director must set a time and place for a hearing held in accordance with 16 TAC § 22.299 to affirm, modify, or set aside the emergency order.

An emergency order issued under Subchapter P of 16 TAC § 22 must contain a description of the condition justifying the issuance of the order; any findings of fact required; a statement on the term of the order, including the dates on which the order will begin and end; and a description of the action sought.¹² The term of an emergency order issued in accordance with 16 TAC § 24.14(a)(1) is limited to 180 days, though it may be renewed once for a period not to exceed 180 days.¹³

II. FACTUAL ALLEGATIONS

Marion J. Smith dba Smith Management Services (SMS) holds certificate of convenience and necessity number 11168, issued by the Texas Water Commission on September 30, 1991.¹⁴ SMS operates four public water systems in Lubbock County: (1) Town North Village Water System, ¹⁵ (2) Plott Acres, ¹⁶ (3) Cox Addition Water System, ¹⁷ and (4) Town North Estates. ¹⁸ Collectively, the four public water systems serve approximately 298 connections. As a person or corporation owning or operating for compensation facilities for the distribution, sale, or provision of potable water to the public, SMS is a utility as defined by the TWC and Commission rules. ¹⁹

On April 20, 2021, the Texas Commission for Environmental Quality's Lubbock Regional office received five separate complaints of a water outage at Town North Village Water System.²⁰ Complainants also informed TCEQ Staff that they were unable to contact utility representatives of SMS for weeks. In response to the complaints, TCEQ Staff determined that the listed owner and operator of SMS, Marion J. Smith, passed away in January 2021.²¹ At the time of his death, the

utility was being operated by Jimmy Midkiff, who, during the spring of 2021, suffered a serious medical emergency which caused him to stop operating the utility completely. TCEQ Staff determined that the water outage was caused when electric power was shut off to the system due to nonpayment of electric bills.²²

Additionally, on April 21, 2021, TCEQ Staff documented SMS' failures to maintain appropriate water treatment at Town North Village Water System, Plott Acres, and Town North Estates, and found that no licensed operator could be identified at any of the four public water systems.²³ SMS failed to notify its customers of potential health hazards²⁴ and did not secure an alternative water supply during the April 20, 2021 outage.²⁵

Finally, TCEQ's investigation found that all real property associated with SMS is owned by the Estate of Marion J. Smith, and that Lubbock County Court named Margenell Smith as executor of the Estate of Marion J. Smith.²⁶ As of April 14, 2022, probate of the estate remained ongoing under case number 2021-767/895 in Lubbock County.

On May 5, 2021, the executive director of TCEQ issued an emergency order appointing Intermediary Solutions Holdings LLC as temporary manager of SMS.²⁷ On July 7, 2021, TCEQ modified the emergency order appointing Intermediary Solutions as temporary manager for a term that expired on November 1, 2021.²⁸ On November 2, 2021, the executive director of TCEQ issued a second emergency order renewing the appointment of Intermediary Solutions as temporary manager.²⁹ On January 19, 2022, TCEQ affirmed Intermediary Solution's re-appointment for a term set to expire on May 1, 2022.³⁰

III. RECOMMENDATION FOR APPOINTMENT OF A TEMPORARY MANAGER

Commission Staff recommends that the executive director appoint a temporary manager for SMS under TWC § 13.4132 and 16 TAC §§ 24.355 and 24.357. The utility has abandoned operations by failing to pay a bill to an electric utility with the result of discontinuance of service, ³¹ failing to provide appropriate water treatment so that a potential health hazard results, ³² failing to provide customers adequate notice of a health hazard or potential health hazard, ³³ failing to secure an alternative available water supply during an outage, ³⁴ and repeatedly failing to respond to the utility's customers. ³⁵

Commission Staff recommends that the executive director appoint Intermediary Solutions as temporary manager. Intermediary Solutions has served as temporary manager since May 5, 2021 and is willing to continue serving as temporary manager.

Commission Staff requests that the emergency order appointing a temporary manager for SMS become effective May 2, 2022 and remain in effect for 180 days or until Intermediary Solutions is discharged from these responsibilities by the Commission or a superseding action is taken by an appropriate court, whichever occurs earlier. Commission Staff further requests that the order include a requirement that Intermediary Solutions maintain its operator licenses and comply with TCEQ rules for the duration of its appointment as temporary manager. Finally, Commission Staff requests a waiver of the requirement in 16 TAC § 24.357(c) regarding the temporary manager's duty to post financial assurance with the Commission. A proposed emergency order is included with this request as Attachment 4.

IV. TEMPORARY MANAGER COMPENSATION

Under 16 TAC § 24.357(f), a temporary manager may be compensated for its services. The compensation amount is to come from utility revenues and is set by the Commission at the time of appointment. Commission Staff respectfully requests that the executive director establish a rate of \$12.00 per connection per month as Intermediary Solutions' compensation for its work as temporary manager for SMS. This is the same amount authorized in the two emergency orders issued by TCEQ.³⁶

V. HEARING TO AFFIRM, MODIFY OR SET ASIDE THE ORDER

Under 16 TAC § 22.297(d)(1), an emergency order issued without a hearing is not subject to the requirements of the APA. However, the executive director must set a time and place for a hearing to be held before the Commission or the State Office of Administrative Hearings to affirm, modify, or set aside the order as soon as practicable.³⁷ Commission Staff recommends that the hearing to affirm, modify, or set aside should be set for the Commission's open meeting currently scheduled for May 12, 2022, at the Commission's offices in Austin, Texas.


For the reasons detailed above, Commission Staff respectfully requests that the executive director issue an emergency order to appoint Intermediary Solutions as temporary manager of SMS.



On May 5, 2021, the Executive Director of the Texas Commission on Environmental Quality (the "Commission" or "TCEQ") issued this Emergency Order pursuant to Tex. Water Code chs. 5 and 13, Tex. Health & Safety Code ch. 341, and 30 Tex, ADMIN, CODE chs. 35, 290, and 291. The party made subject to this Emergency Order is Margenell Smith, Executor of the Estate of Marion J. Smith.

I. FINDINGS OF FACT

- 1. The Estate of Marion J. Smith owns the following public water systems: (1) Town North Village, located at 7916 County Road 5840, Lubbock County, Texas; (2) Plott Acres, located at 8604 County Road 6440, Lubbock County, Texas; (3) Cox Addition, located at 5812 County Road 6150, Lubbock County, Texas; and (4)Town North Estates located at 6823 County Road 1630 in Lubbock County, Texas (collectively, the "Utility")1
- 2. The Utility operates pursuant to Certificate of Convenience and Necessity No. 11168 ("CCN 11168").2 (Exhibit A)
- 3. The Utility provides potable water service for compensation to approximately 120 service connections at Town North Village; approximately 68 service connections at Plott Acres; approximately 38 service connections at Cox Addition; and approximately 72 service connections at Town North Estates. Each system serves at least 25 people per day for at least 60 days per year, and provides water for human consumption. As such, the Utility consists of four public water systems as defined in 30 Tex. ADMIN. Cope § 290,38(71).

¹ All real Property that the Utility is located on is owned by either The Estate of Marion J. Smith or Smith Management Services, which is an assumed name of Marion J. Smith for business conducted as a Sole Proprietorship. The Lubbock County Court has named Margenell Smith as executor of The Estate of Marion J. Smith. At the time of this Order, probate of the estate is ongoing under the case number 2021-767/895 in Lubbock County, TCEQ has not received information indicating that the Utility has been distributed from the Estate.

4. Commission records show that the last known mailing address for Margenell Smith, Executor of the Estate of Marion J. Smith is:

4409 9th Street Lubbock, Texas 79416

- 5. On April 20, 2021, the TCEQ Lubbock Regional office received numerous complaints of a water outage at Town North Village; complainants also reported that they had been unable to get in contact with anyone representing the Utility in weeks.³
- 6. On the evening of April 20, 2021, a TCEQ investigator confirmed that there was a water outage at Town North Village and documented that there was no water pressure at the system. The Investigator determined that the outage was caused when electric power was shut off to the system due to nonpayment of electric bills.
- 7. In response to the complaints, the Lubbock Regional office investigated the situation and found that the listed owner and operator of the Utility, Marion J. Smith, had passed away in January of 2021. Investigators also found that at the time of Marion Smith's death the Utility was being operated by Jimmy Midkiff, and that during the spring of 2021 Mr. Midkiff suffered a severe medical emergency causing him to cease operating the Utility completely.⁴
- 8. On April 22, 2021, a TCEQ investigator conducted investigations at all four public water systems of the Utility. The investigator documented that the Utility:
 - a. Failed to maintain a minimum disinfectant residual throughout the distribution system, in violation of 30 Tex. ADMIN. CODE § 290.110(b)(4).
 - i. At Town North Village, the free chlorine residual at the time of the investigation was 0.03 milligram per liter (mg/L) at 7916 County Road 5840 in Shallowater, Texas; 0.04 mg/L at 8014 County Road 5840 in Shallowater, Texas; and 0.00 mg/L at 8226 County Road 5830 in Shallowater, Texas.
 - ii. At Plott Acres, the free chlorine residual at the time of the investigation was 0.13 mg/L at 8604 County Road 6440 near Lubbock, Texas; and 0.14 mg/L at 2103 North County Road 1440 near Lubbock, Texas.
 - iii. At Town North Estates, the free chlorine residual at the time of the investigation was between .001 and .002 mg/L at 6823 County Road 1630 in Shallowater, Texas; and .003 mg/L at

6909 County Road 6130 in Shallowater, Texas.

- b. Failed to have a licensed operator on site, in violation of 30 Tex. ADMIN. CODE § 290.46(e). Investigators could not identify a person at any of the four public water systems that was serving as an operator.
- 9. The Utility failed to issue a Boil Water Notice ("BWN") to the customers of Town North Village after the April 20, 2021 water outage, in violation of 30 TEX. ADMIN. CODE § 290.46(q).
- 10. On April 23, 2021, The Lubbock Regional Office posted BWNs at all four systems of the Utility due to the water outage at Town North Village and the failure to maintain minimum disinfectant residual at Town North Village, Town North Estates, and Plott Acres.
- 11. The TCEQ alleges that the Utility has (1) failed to provide appropriate water treatment resulting in potential health hazards; (2) failed to adequately maintain facilities, resulting in potential health hazards, extended outages, and repeated service interruptions; (3) failed to provide customers notice of a potential health hazard; and (4) demonstrated a pattern of failing to respond to the TCEQ or the Utility's customers.
- 12. No other source of water is available to the more than 25 people whose water is supplied by the Utility.
- 13. A potential health hazard exists as a result of the Utility's inability to provide continuous and adequate service. A licensed operator is immediately required to ensure the quality of the water in the State and to ensure the Utility operates in a safe manner and meets requirements in the Texas Water Code, the Texas Health and Safety Code, and TCEQ rules. Therefore, a temporary manager is necessary to assume operations of the Utility to ensure the quality of the water meets TCEQ rule requirements and complies with the Texas Water Code as well as the Texas Health and Safety Code, and is safe for public use and consumption.
- 14. Intermediary Solutions Holdings LLC ("Intermediary Solutions") has agreed to serve as temporary manager of the Utility. Intermediary Solutions has designated Mr. Brian Parker as their point of contact. Mr. Parker can be reached by telephone at (214) 799-5156, and by mail at 5 Sawgrass Court, Frisco, Texas 75034. ⁵
- 15. This Emergency Order is necessary to ensure that continuous and adequate water service is provided to the customers of the Utility to effectuate the purposes of the Texas Water Code and the Texas Health and Safety Code.

II. CONCLUSIONS OF LAW

1. As evidenced by Findings of Fact Nos. 1 through 3, The Estate of Marion J.

Smith owns the retail public utility as defined in Tex. WATER CODE § 13.002(19).

- 2. Findings of Fact Nos. 5 through 13 show that as of the date of the signing of this Emergency Order the Utility has been abandoned and that the appointment of a temporary manager is justified as defined in Tex. WATER CODE §§ 13.412(f) and 13.4132 and 30 Tex. ADMIN. CODE § 291.142 (a) and (c).
- 3. TEX. WATER CODE § 13.4132 authorizes the Commission to appoint a willing person to temporarily manage and operate a utility if the utility has discontinued service or abandoned operations or the provision of services as defined by Tex. WATER CODE § 13.412.
- 4. TEX. WATER CODE § 5.507 provides that the Commission may issue an Emergency Order appointing a willing person to temporarily manage and operate a utility under Tex. WATER CODE § 13.4132.
- 5. This Emergency Order may be issued without notice or hearing pursuant to TEX. WATER CODE § 5.501(b) and 30 TEX. ADMIN. CODE § 35.25.
- 6. TEX. WATER CODE § 5.501(c) and 30 TEX. ADMIN CODE §§ 35.12 and 291.143(a) authorize the TCEQ Executive Director to issue this Emergency Order.
- 7. TEX. WATER CODE §§ 5.501 and 5.507 and 30 TEX. ADMIN. CODE § 291.143(a) authorize the Executive Director to appoint a person to temporarily manage and operate a utility that has discontinued or abandoned operations.
- 8. TEX. WATER CODE § 13.4132 provides to the temporary manager the powers and duties necessary to ensure continued operation of the utility and the provision of continuous and adequate services to customers including the power and duty to read meters, bill for services, collect revenues, disburse funds, access all system components, and request rate increases.
- 9. Notice of the Emergency Order, once it has been issued, is adequate if the notice is mailed or hand delivered to the last known address of the Utility's headquarters, in accordance with Tex. WATER CODE § 5.507. The last known address for Margenell Smith, Executor of the Estate of Marion J. Smith is set forth in Finding of Fact No. 4.

III. ORDER

- 1. This Emergency Order shall be effective on the date it is executed by the TCEQ Executive Director, i.e. May 5, 2021.

- 5. Intermediary Solutions shall give the Executive Director an inventory of all Utility property received within sixty (60) days of the effective date of this Emergency Order.
- 6. Intermediary Solutions' requirement to post financial assurance with the TCEQ in an amount and type acceptable to the Executive Director has been waived by the Executive Director pursuant to 30 Tex. ADMIN. CODE § 291.143(c).
- 7. Intermediary Solutions' compensation will come from Utility revenues in the amount of twelve dollars (\$12.00) per month per connection.

The Emergency Order was affixed to the fences surrounding Town North Village, Plott Acres, Cox Addition, and Town North Estates. The Commission finds that the Executive Director appropriately issued the Emergency Order and that the requirements for an emergency order found in Chapters 5 and 13 of the Texas Water Code have been satisfied.

NOW, THEREFORE, THE TEXAS COMMISSION ON ENVIRONMENTAL QUALITY ORDERS THAT:

The November 2, 2021, Emergency Order Renewing the Appointment of a Temporary Manager of a Water Utility, attached hereto as Exhibit A and incorporated into this Order by reference, is affirmed.

EMERGENCY ORDER RENEWING THE APPOINTMENT OF A TEMPORARY MANAGER OF A WATER UTILITY

On November 2, 2021, the Executive Director of the Texas Commission on Environmental Quality (the "Commission" or "TCEQ") issued this Emergency Order pursuant to Tex. Water Code chs. 5 and 13, Tex. Health & Safety Code ch. 341, and 30 Tex. Admin. Code chs. 35, 290, and 291. The party made subject to this Emergency Order is Margenell Smith, Executor of the Estate of Marion J. Smith.

I. FINDINGS OF FACT

- 1. The Estate of Marion J. Smith owns the following public water systems: (1) Town North Village, located at 7916 County Road 5840, Lubbock County, Texas; (2) Plott Acres, located at 8604 County Road 6440, Lubbock County, Texas; (3) Cox Addition, located at 5812 County Road 6150, Lubbock County, Texas; and (4) Town North Estates located at 6823 County Road 1630 in Lubbock County, Texas (collectively, the "Utility").
- 2. The Utility operates pursuant to Certificate of Convenience and Necessity No. 11168 ("CCN 11168"). (Exhibit A)
- 3. The Utility provides potable water service for compensation to approximately 120 service connections at Town North Village; approximately 68 service connections at Plott Acres; approximately 38 service connections at Cox Addition; and approximately 72 service connections at Town North Estates. Each system serves at least 25 people per day for at least 60 days per year, and provides water for human consumption. As such, the Utility consists of four public water systems as defined in 30 Tex. ADMIN. CODE § 290.38(71).
- Commission records show that the last known mailing address for Margenell Smith, Executor of the Estate of Marion J. Smith is:

¹ All real Property that the Utility is located on is owned by either The Estate of Marion J. Smith or Smith Management Services, which is an assumed name of Marion J. Smith for business conducted as a Sole Proprietorship. The Lubbock County Court has named Margenell Smith as executor of The Estate of Marion J. Smith. At the time of this Order, probate of the estate is ongoing under the case number 2021-767/895 in Lubbock County. TCEQ has not received information indicating that the Utility has been distributed from the Estate.

² The CCN is held by Marion J. Smith dba Smith Management Services.

- 5. On April 20, 2021, the TCEQ Lubbock Regional office received numerous complaints of a water outage at Town North Village; complainants also reported that they had been unable to get in contact with anyone representing the Utility in weeks.³
- 6. On the evening of April 20, 2021, a TCEQ investigator confirmed that there was a water outage at Town North Village and documented that there was no water pressure at the system. The Investigator determined that the outage was caused when electric power was shut off to the system due to nonpayment of electric bills.
- 7. In response to the complaints, the Lubbock Regional office investigated the situation and found that the listed owner and operator of the Utility, Marion J. Smith, had passed away in January of 2021. Investigators also found that at the time of Marion Smith's death the Utility was being operated by Jimmy Midkiff, and that during the spring of 2021 Mr. Midkiff suffered a severe medical emergency causing him to cease operating the Utility completely.⁴
- 8. On April 22, 2021, a TCEQ investigator conducted investigations at all four public water systems of the Utility. The investigator documented that the Utility:
 - a. Failed to maintain a minimum disinfectant residual throughout the distribution system, in violation of 30 Tex. ADMIN. CODE § 290.110(b)(4).
 - At Town North Village, the free chlorine residual at the time of the investigation was 0.03 milligram per liter (mg/L) at 7916 County Road 5840 in Shallowater, Texas; 0.04 mg/L at 8014 County Road 5840 in Shallowater, Texas; and 0.00 mg/L at 8226 County Road 5830 in Shallowater, Texas.
 - ii. At Plott Acres, the free chlorine residual at the time of the investigation was 0.13 mg/L at 8604 County Road 6440 near Lubbock, Texas; and 0.14 mg/L at 2103 North County Road 1440 near Lubbock, Texas.
 - iii. At Town North Estates, the free chlorine residual at the time of the investigation was between .001 and .002 mg/L at 6823 County Road 1630 in Shallowater, Texas; and .003 mg/L at 6909 County Road 6130 in Shallowater. Texas.
 - b. Failed to have a licensed operator on site, in violation of 30 Tex. ADMIN. CODE § 290.46(e). Investigators could not identify a person at any of the four public water systems that was serving as an operator.
- 9. The Utility failed to issue a Boil Water Notice ("BWN") to the customers of Town North Village after the April 20, 2021 water outage, in violation of 30 Tex. ADMIN. CODE § 290.46(g).
- 10. On April 23, 2021, The Lubbock Regional Office posted BWNs at all four systems of the Utility due to the water outage at Town North Village and the failure to maintain minimum disinfectant residual at Town North Village, Town North Estates, and Plott Acres.
- 11. The TCEQ alleges that the Utility has (1) failed to provide appropriate water treatment resulting in potential health hazards; (2) failed to adequately maintain facilities, resulting in potential health hazards, extended outages, and repeated service

³ Five separate complaints were received on April 20, 2021; the first complaint came in at approximately 10:00am. Complaints were about water outages, low chlorine, low water pressure, and inability to contact an operator. Complaints were received for all four water systems.

^{*} Mr. Midkiff does not hold the CCN for the Utility nor has he submitted a Sale Transfer Merger application to the PUC to purchase the Utility.

interruptions; (3) failed to provide customers notice of a potential health hazard; and (4) demonstrated a pattern of failing to respond to the TCEQ or the Utility's customers.

- 12. No other source of water is available to the more than 25 people whose water is supplied by the Utility.
- 13. TCEQ Appointed Intermediary Solutions Holdings LLC ("Intermediary Solutions") as temporary manager for the Utility through an Emergency Order issued on May 5, 2021, and affirmed by the Commission on June 30, 2021, for the purpose of providing continuous and adequate water service to customers. Intermediary Solutions appointment as Temporary manager expired on November 1, 2021.
- 14. During Intermediary Solutions' first term as Temporary Manager, Intermediary Solutions installed new self-contained chlorination systems at all four systems, started maintaining a minimum disinfectant residual throughout the distribution system of all four water systems, and made various repairs necessary for the maintenance of the systems. As Temporary Manager, Intermediary Solutions has provided continuous and adequate water service to the customers of the four water systems owned by the Estate of Marion J. Smith.
- 15. A potential health hazard exists as a result of the Utility's inability to provide continuous and adequate service. A licensed operator is immediately required to ensure the quality of the water in the State and to ensure the Utility operates in a safe manner and meets requirements in the Texas Water Code, the Texas Health and Safety Code, and TCEQ rules. Therefore, a temporary manager is necessary to assume operations of the Utility to ensure the quality of the water meets TCEQ rule requirements and complies with the Texas Water Code as well as the Texas Health and Safety Code, and is safe for public use and consumption.
- 16. Intermediary Solutions has agreed to serve as temporary manager of the Utility. Intermediary Solutions has designated Mr. Brian Parker as their point of contact. Mr. Parker can be reached by telephone at (214) 799-5156, and by mail at 5 Sawgrass Court, Frisco, Texas 75034.
- 17. This Emergency Order is necessary to ensure that continuous and adequate water service is provided to the customers of the Utility to effectuate the purposes of the Texas Water Code and the Texas Health and Safety Code.

II. CONCLUSIONS OF LAW

- 1. As evidenced by Findings of Fact Nos. 1 through 3, The Estate of Marion J. Smith owns the retail public utility as defined in Tex. WATER CODE § 13.002(19).
- 2. Findings of Fact Nos. 5 through 15 show that as of the date of the signing of this Emergency Order the Utility has been abandoned and that the appointment of a temporary manager is justified as defined in Tex. WATER CODE §§ 13.412(f) and 13.4132 and 30 Tex. Admin. Code § 291.142 (a) and (c).
- 3. Tex. Water Code § 13.4132 authorizes the Commission to appoint a willing person to temporarily manage and operate a utility if the utility has discontinued service or abandoned operations or the provision of services as defined by Tex. Water Code § 13.412.

⁵ Intermediary Solutions operates a nearby water system in Lubbock County and Brian Parker is a TCEQlicensed operator.

- 4. Tex. Water Code § 5.507 provides that the Commission may issue an Emergency Order appointing a willing person to temporarily manage and operate a utility under Tex. Water Code § 13.4132.
- 5. This Emergency Order may be issued without notice or hearing pursuant to Tex. WATER CODE § 5.501(b) and 30 Tex. ADMN. CODE § 35.25.
- 6. TEX. WATER CODE § 5.501(c) and 30 TEX. ADMIN CODE §§ 35.12 and 291.143(a) authorize the TCEQ Executive Director to issue this Emergency Order.
- 7. TEX. WATER CODE §§ 5.501 and 5.507 and 30 TEX. ADMIN. CODE § 291.143(a) authorize the Executive Director to appoint a person to temporarily manage and operate a utility that has discontinued or abandoned operations.
- 8. Tex. Water Code § 13.4132 provides to the temporary manager the powers and duties necessary to ensure continued operation of the utility and the provision of continuous and adequate services to customers including the power and duty to read meters, bill for services, collect revenues, disburse funds, access all system components, and request rate increases.
- 9. Notice of the Emergency Order, once it has been issued, is adequate if the notice is mailed or hand delivered to the last known address of the Utility's headquarters, in accordance with Tex. WATER CODE § 5.507. The last known address for Margenell Smith, Executor of the Estate of Marion J. Smith is set forth in Finding of Fact No. 4.

III. ORDER

- 1. This Emergency Order shall be effective on the date it is executed by the TCEQ Executive Director, i.e. November 2, 2021.
- 2. Immediately upon the effective date of this Emergency Order, Intermediary Solutions Holdings LLC is hereby appointed to temporarily manage and operate the Utility.
- 3. Intermediary Solutions shall serve as temporary manager until 180 days after the effective date of this Emergency Order i.e. May 1, 2022.
- 4. Intermediary Solutions is authorized to exercise those powers and duties necessary to ensure the continued operations of the Utility and the provision of continuous and adequate services to customers, including the powers and duties set forth in Tex. WATER CODE § 13.4132.
- 5. Intermediary Solutions shall give the Executive Director an inventory of all Utility property received within sixty (60) days of the effective date of this Emergency Order.
- 6. Intermediary Solutions' requirement to post financial assurance with the TCEQ in an amount and type acceptable to the Executive Director has been waived by the Executive Director pursuant to 30 Tex. ADMIN. CODE § 291.143(c).
- 7. Intermediary Solutions' compensation will come from Utility revenues in the amount of twelve dollars (\$12.00) per month per connection.
- 8. Intermediary Solutions shall report to the Executive Director on a monthly basis in accordance with 30 Tex. ADMIN. CODE § 291.143(h).
- 9. Pursuant to Tex. Water Code § 5.504, the Commission will consider whether to affirm,

modify or set aside this Emergency Order at its regular Agenda meeting on January 12, 2022 at 9:30 a.m., at TCEQ Park 35 Complex, 12118 North I-35, Building E, Room 201S, Austin, Texas.⁶ At the January 12, 2022 Agenda meeting, Margenell Smith, Executor of the Estate of Marion J. Smith, may request an evidentiary hearing pursuant to 30 Tex. ADMIN. CODE § 35.25(c) for the purpose of presenting evidence and cross-examining witnesses regarding whether to affirm, modify, or set aside this Emergency Order.

10. The Chief Clerk shall provide a copy of this Emergency Order to each of the parties.

EMERGENCY ORDER APPOINTING A TEMPORARY MANAGER FOR MARION J. SMITH DBA SMITH MANAGEMENT SERVICES WITHOUT A HEARING

This Order addresses the request filed by the Staff of Public Utility Commission of Texas for an emergency order appointing a temporary manager to Marion J. Smith dba Smith Management Services. The executive director, on behalf of the Commission, issues this emergency order without a hearing, and sets a hearing on this matter to be held as soon as practicable at the Open Meeting scheduled for May 12, 2022, to be held at the Commission's offices in Austin, Texas.

I. Findings of Fact

The Commission makes the following findings of fact:

- 1. Commission Staff, as the requesting party, is located at 1701 N. Congress Avenue, 7th Floor, Austin, Texas 78701.
- Marion J. Smith dba Smith Management Services owns and operates for compensation facilities and equipment for the transmission, storage, distribution, sale or provision of water service to the public.
- 3. Smith Management Services owns and operates four public water systems: Town North Village Water System,¹ (2) Plott Acres,² (3) Cox Addition Water System,³ and (4) Town North Estates.⁴

4. On September 30, 1991, the Texas Water Commission granted certificate of convenience and necessity number 11168 to Smith Management Services.

- 5. The four public water systems currently serve approximately 298 connections.
- 6. On April 20, 2021, the Texas Commission for Environmental Quality received five separate complaints of a water outage at Town North Village Water System.
- 7. The complainants also reported that they had been unable to contact anyone representing Town North Village Water System for weeks.
- 8. On April 20, 2021, TCEQ staff confirmed the water outage at Town North Village Water System and determined the cause to be related to disconnection of electric service due to unpaid bills.
- 9. On April 22, 2021, TCEQ staff conducted investigations at all four public water systems and found that Smith Management Services failed to have a licensed operator at each of the system's facilities.
- 10. TCEQ's investigation determined that Smith Management Services failed to maintain minimum disinfectant residual throughout the distribution systems of Town North Village Water System, Plott Acres, and Town North Estates.
- 11. TCEQ's investigation determined that Smith Management Services failed to issue a boil water notice to the customers of Town North Village Water System.
- 12. TCEQ's investigation discovered that the listed owner and operator of Smith Management Services, Mr. Marion J. Smith, had passed away in January 2021, and that, at the time of his death, Mr. Jimmy Midkiff was operating the systems on his behalf without certification.
- 13. TCEQ's investigation discovered that Mr. Midkiff suffered a severe medical emergency during the spring of 2021, which caused him to stop operating the water systems completely.
- 14. TCEQ's investigation determined that no other source of water was available to more than25 people whose water is supplied by Smith Management Services.

15. On May 5, 2021, the executive director of TCEQ issued an emergency order appointing Intermediary Solutions Holdings, LLC as temporary manager of Smith Management Services and its four public water systems for a term that expired on November 1, 2021.

- 16. On July 7, 2021, TCEQ issued an order modifying the May 5, 2021 emergency order and maintained Intermediary Solutions' appointment as temporary manager.
- 17. On November 2, 2021, the executive director of TCEQ issued an emergency order renewing Intermediary Solutions' appointment as temporary manager for a term set to expire on May 1, 2022.
- 18. On January 12, 2022, TCEQ issued an order affirming the November 2, 2021 emergency order and maintained Intermediary Solutions' appointment as temporary manager.
- 11. On DATE, Commission Staff filed a request for an emergency order appointing a person to temporarily manage Smith Management Services and its four public water systems.
- 12. In its request, Commission Staff recommended the executive director appoint Intermediary Solutions Holdings, LLC as temporary manager.
- 13. Intermediary Solutions is the owner of North University Estates Water Company, which provides retail water service in Lubbock County under certificate of convenience and necessity number 12179.
- Intermediary Solutions employs a TCEQ-licensed water operator who will operate Smith Management Services' four public water systems.
- 15. Intermediary Solutions is willing to serve as temporary manager.
- 16. In its request, Commission Staff recommended that Intermediary Solutions receive compensation of \$12.00 per connection per month for its services as temporary manager.
- 17. Commission Staff recommended the emergency order appointing Intermediary Solutions as temporary manager begin on May 2, 2022 and end on November 1, 2022, or when Intermediary Solutions is discharged from these responsibilities by the Commission or a superseding action is taken by an appropriate court, whichever occurs first.

II. Conclusions of Law

The Commission makes the following conclusions of law:

1. The Commission has jurisdiction over this matter under Texas Water Code (TWC) § 13.4132(b) and 16 Texas Administrative Code (TAC) § 24.14(a)(1).

- 2. Under TWC § 13.451(b), the Commission may, by order or rule, delegate to the executive director the authority to issue an emergency order under Subchapter K-1 of the TWC. The delegation was made by Commission order on December 4, 2015, in Docket No. 43517.
- Marion J. Smith dba Smith Management Services is a water utility as defined in TWC § 13.002(23) and 16 TAC § 24.3(39).
- 4. Under TWC § 13.4132 and 16 TAC § 24.357, the Commission may authorize a willing person to temporarily manage and operate a utility if the utility has abandoned operations.
- 5. TWC § 13.412(f) and 16 TAC § 24.355(c) enumerate actions that constitute abandonment, which include but are not limited to, failure to pay a bill to an electric utility with the result of discontinuance of service, failure to provide appropriate water treatment so that a potential health hazard results, failure to provide customers adequate notice of a health hazard or potential health hazard, failure to secure an alternative available water supply during an outage, and repeated failure to respond to the utility's customers
- 6. Smith Management Services abandoned the operation of its facilities under TWC § 13.412(f)(1) and 16 TAC § 24.355(c)(1) when it failed to pay a bill to an electric utility which resulted in the discontinuance of necessary services.
- 7. Smith Management Services abandoned the operation of its facilities under TWC § 13.412(f)(2) and 16 TAC § 24.355(c)(2) when it failed to maintain minimum disinfectant residuals throughout its distribution systems.
- 8. Smith Management Services abandoned the operation of its facilities under TWC § 13.412(f)(4) and 16 TAC § 24.355(c)(4) when it failed to issue a boil water notice to customers affected by a water outage.
- 9. Smith Management Services abandoned the operation of its facilities under TWC § 13.412(f)(5) and 16 TAC § 24.355(c)(5) when it failed to secure an alternative available water supply during an outage.

10. Smith Management Services abandoned the operation of its facilities under TWC § 13.412(f)(6) and 16 TAC § 24.355(c)(6) when it repeatedly failed to respond to the utilities' customers.

- 11. Under 16 TAC § 24.357(f), compensation for the temporary manager will come from utility revenues and will be set by the Commission at the time of appointment.
- 12. Under TWC § 13.451(a) and 16 TAC §§ 24.14(a)(1), 24.355(b), and 22.299(d), an emergency order to appoint a temporary manager may be issued with or without a hearing.

III. Ordering Paragraphs

In accordance with these findings of facts and conclusions of law, the Commission issues the following Order:

- Commission Staff's request for an order appointing Intermediary Solutions Holdings, LLC
 to temporarily manage and operate Marion J. Smith dba Smith Management Services is
 granted.
- 2. Intermediary Solutions is appointed temporary manager for Town North Village Water System, Plott Acres, Cox Addition Water System, and Town North Estates public water systems for a term of 180 days to begin on May 2, 2022 and to end on November 1, 2022, or when Intermediary Solutions is discharged from these responsibilities by the Commission or a superseding action is taken by an appropriate court, whichever occurs first.
- 3. Intermediary Solutions has all the powers and duties necessary to ensure the continued operation of Town North Village Water System, Plott Acres, Cox Addition Water System, and Town North Estates and the provision of continuous and adequate service to their customers.
- 4. As temporary manager, Intermediary Solutions must comply with all requirements in 16 TAC § 24.357, including but not limited to reading meters, billing for utility service, collecting revenues, disbursing funds, requesting rate increases if needed, accessing all system components, conducting required sampling, making necessary repairs, and

- performing other acts necessary to ensure continuous and adequate utility service as authorized by the Commission.
- 5. Intermediary Solutions must return to the Commission an inventory of all property received within 60 days of its appointment in accordance with 16 TAC § 24.357(e).
- 6. Intermediary Solutions must report to the Commission on a monthly basis. This report must include an income statement for the reporting period; a summary of utility activities, such as improvements or major repairs made, number of connections added, and amount of water produced or treated; and any other information required by the Commission in accordance with 16 TAC § 24.357(h).
- 7. Intermediary Solutions must maintain employment of a TCEQ-licensed water operator for the duration of its appointment as temporary manager.
- 8. Intermediary Solutions must comply with all applicable requirements imposed by the Texas Commission on Environmental Quality.
- 9. Intermediary Solutions is not required to post financial assurance.
- Intermediary Solutions will be compensated \$12.00 per connection per month for its services as temporary manager.
- 11. Commission Staff must provide notice of issuance of this emergency order to Town North Village Water System, Plott Acres, Cox Addition Water System, and Town North Estates as soon as practicable in accordance with 16 TAC § 22.293(c).
- 12. Intermediary Solutions must provide notice of issuance of this emergency order to the customers of Town North Village, Plott Acres, Cox Addition, and Town North Estates in accordance with 16 TAC § 24.293(e).
- 13. A hearing to affirm, modify, or set aside this emergency order will be held during the Commission's Open Meeting scheduled for May 12, 2022, to be held at the Commission's offices in Austin, Texas.
- 14. Commission Staff must provide notice of the opportunity to participate in an evidentiary hearing to affirm, modify, or set aside this emergency order to Smith Management Services no later than the tenth day before the date of the hearing, and the notice must provide that

EMERGENCY ORDER APPOINTING A TEMPORARY MANAGER FOR MARION J. SMITH DBA SMITH MANAGEMENT SERVICES WITHOUT A HEARING

This Order addresses the request filed by the Staff of Public Utility Commission of Texas for an emergency order appointing a temporary manager to Marion J. Smith dba Smith Management Services. The executive director, on behalf of the Commission, issues this emergency order without a hearing, and sets a hearing on this matter to be held as soon as practicable at the Open Meeting scheduled for May 12, 2022, to be held at the Commission's offices in Austin, Texas.

I. Findings of Fact

The Commission makes the following findings of fact:

- 1. Commission Staff, as the requesting party, is located at 1701 N. Congress Avenue, 7th Floor, Austin, Texas 78701.
- Marion J. Smith dba Smith Management Services owns and operates for compensation facilities and equipment for the transmission, storage, distribution, sale or provision of water service to the public.
- 3. Smith Management Services owns and operates four public water systems: Town North Village Water System,¹ (2) Plott Acres,² (3) Cox Addition Water System,³ and (4) Town North Estates.⁴

4. On September 30, 1991, the Texas Water Commission granted certificate of convenience and necessity number 11168 to Smith Management Services.

- 5. The four public water systems currently serve approximately 298 connections.
- On April 20, 2021, the Texas Commission for Environmental Quality received five separate complaints of a water outage at Town North Village Water System.
- The complainants also reported that they had been unable to contact anyone representing Town North Village Water System for weeks.
- On April 20, 2021, TCEQ staff confirmed the water outage at Town North Village Water
 System and determined the cause to be related to disconnection of electric service due to
 unpaid bills.
- On April 22, 2021, TCEQ staff conducted investigations at all four public water systems
 and found that Smith Management Services failed to have a licensed operator at each of
 the system's facilities.
- TCEQ's investigation determined that Smith Management Services failed to maintain minimum disinfectant residual throughout the distribution systems of Town North Village Water System, Plott Acres, and Town North Estates.
- 11. TCEQ's investigation determined that Smith Management Services failed to issue a boil water notice to the customers of Town North Village Water System.
- 12. TCEQ's investigation discovered that the listed owner and operator of Smith Management Services, Mr. Marion J. Smith, had passed away in January 2021, and that, at the time of his death, Mr. Jimmy Midkiff was operating the systems on his behalf without certification.
- 13. TCEQ's investigation discovered that Mr. Midkiff suffered a severe medical emergency during the spring of 2021, which caused him to stop operating the water systems completely.
- 14. TCEQ's investigation determined that no other source of water was available to more than25 people whose water is supplied by Smith Management Services.

15. On May 5, 2021, the executive director of TCEQ issued an emergency order appointing Intermediary Solutions Holdings, LLC as temporary manager of Smith Management Services and its four public water systems for a term that expired on November 1, 2021.

- 16. On July 7, 2021, TCEQ issued an order modifying the May 5, 2021 emergency order and maintained Intermediary Solutions' appointment as temporary manager.
- 17. On November 2, 2021, the executive director of TCEQ issued an emergency order renewing Intermediary Solutions' appointment as temporary manager for a term set to expire on May 1, 2022.
- 18. On January 12, 2022, TCEQ issued an order affirming the November 2, 2021 emergency order and maintained Intermediary Solutions' appointment as temporary manager.
- 11. On April 18, 2022, Commission Staff filed a request for an emergency order appointing a person to temporarily manage Smith Management Services and its four public water systems.
- 12. In its request, Commission Staff recommended the executive director appoint Intermediary Solutions Holdings, LLC as temporary manager.
- Intermediary Solutions is the owner of North University Estates Water Company, which
 provides retail water service in Lubbock County under certificate of convenience and
 necessity number 12179.
- Intermediary Solutions employs a TCEQ-licensed water operator who will operate Smith Management Services' four public water systems.
- 15. Intermediary Solutions is willing to serve as temporary manager.
- 16. In its request, Commission Staff recommended that Intermediary Solutions receive compensation of \$12.00 per connection per month for its services as temporary manager.
- 17. Commission Staff recommended the emergency order appointing Intermediary Solutions as temporary manager begin on May 2, 2022 and end on November 1, 2022, or when Intermediary Solutions is discharged from these responsibilities by the Commission or a superseding action is taken by an appropriate court, whichever occurs first.

II. Conclusions of Law

The Commission makes the following conclusions of law:

1. The Commission has jurisdiction over this matter under Texas Water Code (TWC) § 13.4132(b) and 16 Texas Administrative Code (TAC) § 24.14(a)(1).

- Under TWC § 13.451(b), the Commission may, by order or rule, delegate to the executive director the authority to issue an emergency order under Subchapter K-1 of the TWC. The delegation was made by Commission order on December 4, 2015, in Docket No. 43517.
- Marion J. Smith dba Smith Management Services is a water utility as defined in TWC § 13.002(23) and 16 TAC § 24.3(39).
- 4. Under TWC § 13.4132 and 16 TAC § 24.357, the Commission may authorize a willing person to temporarily manage and operate a utility if the utility has abandoned operations.
- 5. TWC § 13.412(f) and 16 TAC § 24.355(c) enumerate actions that constitute abandonment, which include but are not limited to, failure to pay a bill to an electric utility with the result of discontinuance of service, failure to provide appropriate water treatment so that a potential health hazard results, failure to provide customers adequate notice of a health hazard or potential health hazard, failure to secure an alternative available water supply during an outage, and repeated failure to respond to the utility's customers
- 6. Smith Management Services abandoned the operation of its facilities under TWC § 13.412(f)(1) and 16 TAC § 24.355(c)(1) when it failed to pay a bill to an electric utility which resulted in the discontinuance of necessary services.
- 7. Smith Management Services abandoned the operation of its facilities under TWC § 13.412(f)(2) and 16 TAC § 24.355(c)(2) when it failed to maintain minimum disinfectant residuals throughout its distribution systems.
- 8. Smith Management Services abandoned the operation of its facilities under TWC § 13.412(f)(4) and 16 TAC § 24.355(c)(4) when it failed to issue a boil water notice to customers affected by a water outage.
- 9. Smith Management Services abandoned the operation of its facilities under TWC § 13.412(f)(5) and 16 TAC § 24.355(c)(5) when it failed to secure an alternative available water supply during an outage.

10. Smith Management Services abandoned the operation of its facilities under TWC § 13.412(f)(6) and 16 TAC § 24.355(c)(6) when it repeatedly failed to respond to the utilities' customers.

- 11. Under 16 TAC § 24.357(f), compensation for the temporary manager will come from utility revenues and will be set by the Commission at the time of appointment.
- 12. Under TWC § 13.451(a) and 16 TAC §§ 24.14(a)(1), 24.355(b), and 22.299(d), an emergency order to appoint a temporary manager may be issued with or without a hearing.

III. Ordering Paragraphs

In accordance with these findings of facts and conclusions of law, the Commission issues the following Order:

- Commission Staff's request for an order appointing Intermediary Solutions Holdings, LLC
 to temporarily manage and operate Marion J. Smith dba Smith Management Services is
 granted.
- Intermediary Solutions is appointed temporary manager for Town North Village Water System, Plott Acres, Cox Addition Water System, and Town North Estates public water systems for a term of 180 days to begin on May 2, 2022 and to end on November 1, 2022, or when Intermediary Solutions is discharged from these responsibilities by the Commission or a superseding action is taken by an appropriate court, whichever occurs first.
- Intermediary Solutions has all the powers and duties necessary to ensure the continued operation of Town North Village Water System, Plott Acres, Cox Addition Water System, and Town North Estates and the provision of continuous and adequate service to their customers.
- 4. As temporary manager, Intermediary Solutions must comply with all requirements in 16 TAC § 24.357, including but not limited to reading meters, billing for utility service, collecting revenues, disbursing funds, requesting rate increases if needed, accessing all system components, conducting required sampling, making necessary repairs, and

- performing other acts necessary to ensure continuous and adequate utility service as authorized by the Commission.
- 5. Intermediary Solutions must return to the Commission an inventory of all property received within 60 days of its appointment in accordance with 16 TAC § 24.357(e).
- 6. Intermediary Solutions must report to the Commission on a monthly basis. This report must include an income statement for the reporting period; a summary of utility activities, such as improvements or major repairs made, number of connections added, and amount of water produced or treated; and any other information required by the Commission in accordance with 16 TAC § 24.357(h).
- 7. Intermediary Solutions must maintain employment of a TCEQ-licensed water operator for the duration of its appointment as temporary manager.
- 8. Intermediary Solutions must comply with all applicable requirements imposed by the Texas Commission on Environmental Quality.
- 9. Intermediary Solutions is not required to post financial assurance.
- 10. Intermediary Solutions will be compensated \$12.00 per connection per month for its services as temporary manager.
- 11. Commission Staff must provide notice of issuance of this emergency order to Town North Village Water System, Plott Acres, Cox Addition Water System, and Town North Estates as soon as practicable in accordance with 16 TAC § 22.293(c).
- 12. Intermediary Solutions must provide notice of issuance of this emergency order to the customers of Town North Village, Plott Acres, Cox Addition, and Town North Estates in accordance with 16 TAC § 24.293(e).
- 13. A hearing to affirm, modify, or set aside this emergency order will be held during the Commission's Open Meeting scheduled for May 12, 2022, to be held at the Commission's offices in Austin, Texas.
- 14. Commission Staff must provide notice of the opportunity to participate in an evidentiary hearing to affirm, modify, or set aside this emergency order to Smith Management Services no later than the tenth day before the date of the hearing, and the notice must provide that

Smith dba Smith Management Services (collectively referred to as the "Water Systems") located in Lubbock County. Notice of the petition was mailed on April 19, 2022, to the last known address of the Water Systems listed in Commission Staff's petition.

On April 19, 2022, under authority delegated by the Commission, the executive director granted the petition and appointed Intermediary Solutions Holdings, LLC as temporary manager of the Water Systems. The appointment is effective May 2, 2022.

The emergency order was issued without a hearing under the authority provided by §§ 13.4132 and 13.451 of the Texas Water Code (TWC) and 16 Texas Administrative Code (TAC) §§ 24.14(a)(1), 24.355(b), and 22.299(d). TWC § 13.451 authorizes the Commission to issue an emergency order after providing notice and opportunity for a hearing that the Commission considers practicable under the circumstances or without notice or opportunity for a hearing. In accordance with 16 TAC § 22.297, Commission Staff provides the following notice of a hearing to affirm, modify, or set aside the emergency order issued without hearing on April 19, 2022:

EMERGENCY ORDER HEARINGS: In accordance with TWC § 13.451 and 16 TAC § 22.297, a hearing to affirm, modify, or set aside the emergency order will be held at the Commission's Open Meeting scheduled to begin at 9:30 a.m. on May 12, 2022 and take place at the Commission's offices at 1701 N. Congress Avenue, 7th Floor, Austin, Texas 78701.

The Commission will consider evidence on whether to affirm, modify, or set aside the emergency order appointing the temporary manager. Any affected person may participate in the evidentiary hearing or waive the right to such hearing. Waiver of the right to a hearing may occur if an affected person gives written notice of its waiver to the right to hearing to the Commission, or fails to attend the hearing. The hearing will be conducted in accordance with Chapter 2001 of the Texas Government Code, TWC chapter 13, and Commission rules in 16 TAC chapter 24.

BEFORE ME, the undersigned authority, on this day personally appeared Nima Momtahan, and being by me duly sworn, upon oath declared that the statements and capacity acted in are true and correct.

My name is Nima Momtahan. Since September 2021, I have been the Receivership Coordinator for the Public Utility Commission of Texas (Commission). From August 2019 to September 2021, I was Receivership Coordinator for the Texas Commission on Environmental Quality (TCEQ). I am over the age of twenty-one, and I am competent to make this Affidavit.

Marion J. Smith d/b/a Smith Management Services (SMS) is a retail public utility that holds certificate of convenience and necessity number 11168. SMS owns four public water systems in Lubbock County: (1) Town North Village Water System (PWS ID no. 1520094), (2) Plott Acres (PWS ID No. 1520062), (3) Cox Addition Water System (PWS ID No. 1520106), and (4) Town North Estates (PWS ID No. 1520152). Collectively, the four public water systems serve approximately 298 connections.

On April 20, 2021, the TCEQ's Lubbock Regional office received five separate complaints of a water outage at Town North Village Water System. Complainants also informed TCEQ Staff that they were unable to contact utility representatives of SMS for weeks. In response to the complaints, TCEQ Staff determined that the listed owner and operator of SMS, Marion J. Smith,

passed away in January 2021. At the time of his death, the utility was being operated by Jimmy Midkiff, who, during the spring of 2021, suffered a serious medical emergency which caused him to stop operating the utility completely. TCEQ Staff determined that the water outage was caused when electric power was shut off to the system due to nonpayment of electric bills.

Additionally, after investigations at all four public water systems of SMS on April 22, 2021, TCEQ Staff documented SMS' failure to maintain a minimum disinfectant residual throughout the distribution systems at Town North Village, Plott Acres, and Town North Estates, and found that no licensed operator could be identified at any of the four public water systems. SMS also failed to secure an alternative water supply during the April 20, 2021 outage and failed to issue a Boil Water Notice to the customers of Town North Village Water System after the outage.

On May 5, 2021, the executive director of TCEQ issued an emergency order appointing Intermediary Solutions Holdings, LLC (Intermediary) as temporary manager of SMS. On July 7, 2021, TCEQ modified the emergency order appointing Intermediary as temporary manager for a term that expired on November 1, 2021. On November 2, 2021, the executive director of TCEQ issued a second emergency order renewing the appointment of Intermediary as temporary manager. On January 19, 2022, TCEQ affirmed Intermediary's re-appointment for a term set to expire on May 1, 2022.

On April 19, 2022, the executive director of the Commission entered an emergency order appointing Intermediary as temporary manager of SMS for a term set to begin on May 2, 2022 and to end on November 1, 2022. Intermediary has served as temporary manager of SMS since May 5, 2021, and is willing to continue serving as temporary manager. Additionally, Intermediary is the owner of another retail water utility in Lubbock County and employs a licensed water operator who will operate SMS' four public water systems. Therefore, I recommend that the Commission affirm the April 19, 2022 emergency order appointing Intermediary as temporary manager of SMS. I further recommend that the Commission set a rate of \$12.00 per connection per month as Intermediary's compensation for its work as temporary manager for SMS, as \$12.00 is the amount authorized in the two emergency orders issued by TCEQ.²

On May 5, 2021, the Executive Director of the Texas Commission on Environmental Quality (the "Commission" or "TCEQ") issued this Emergency Order pursuant to Tex. Water Code chs. 5 and 13, Tex. Health & Safety Code ch. 341, and 30 Tex. Admin. Code chs. 35, 290, and 291. The party made subject to this Emergency Order is Margenell Smith, Executor of the Estate of Marion J. Smith.

I. FINDINGS OF FACT

- The Estate of Marion J. Smith owns the following public water systems: 1. (1) Town North Village, located at 7916 County Road 5840, Lubbock County, Texas; (2) Plott Acres, located at 8604 County Road 6440, Lubbock County, Texas; (3) Cox Addition, located at 5812 County Road 6150, Lubbock County, Texas; and (4)Town North Estates located at 6823 County Road 1630 in Lubbock County, Texas (collectively, the "Utility")1
- 2. The Utility operates pursuant to Certificate of Convenience and Necessity No. 11168 ("CCN 11168").2 (Exhibit A)
- The Utility provides potable water service for compensation to approximately 3. 120 service connections at Town North Village; approximately 68 service connections at Plott Acres; approximately 38 service connections at Cox Addition; and approximately 72 service connections at Town North Estates. Each system serves at least 25 people per day for at least 60 days per year. and provides water for human consumption. As such, the Utility consists of four public water systems as defined in 30 Tex, ADMIN. Cope § 290,38(71).

¹ All real Property that the Utility is located on is owned by either The Estate of Marion J. Smith or Smith Management Services, which is an assumed name of Marion J. Smith for business conducted as a Sole Proprietorship. The Lubbock County Court has named Margenell Smith as executor of The Estate of Marion J. Smith. At the time of this Order, probate of the estate is ongoing under the case number 2021-767/895 in Lubbock County. TCEQ has not received information indicating that the Utility has been distributed from the Estate.

² The CCN is held by Marion J. Smith dba Smith Management Services.

4. Commission records show that the last known mailing address for Margenell Smith, Executor of the Estate of Marion J. Smith is:

4409 9th Street Lubbock, Texas 79416

- 5. On April 20, 2021, the TCEQ Lubbock Regional office received numerous complaints of a water outage at Town North Village; complainants also reported that they had been unable to get in contact with anyone representing the Utility in weeks.³
- 6. On the evening of April 20, 2021, a TCEQ investigator confirmed that there was a water outage at Town North Village and documented that there was no water pressure at the system. The Investigator determined that the outage was caused when electric power was shut off to the system due to nonpayment of electric bills.
- 7. In response to the complaints, the Lubbock Regional office investigated the situation and found that the listed owner and operator of the Utility, Marion J. Smith, had passed away in January of 2021. Investigators also found that at the time of Marion Smith's death the Utility was being operated by Jimmy Midkiff, and that during the spring of 2021 Mr. Midkiff suffered a severe medical emergency causing him to cease operating the Utility completely.⁴
- 8. On April 22, 2021, a TCEQ investigator conducted investigations at all four public water systems of the Utility. The investigator documented that the Utility:
 - a. Failed to maintain a minimum disinfectant residual throughout the distribution system, in violation of 30 Tex. ADMIN. CODE § 290.110(b)(4).
 - At Town North Village, the free chlorine residual at the time of the investigation was 0.03 milligram per liter (mg/L) at 7916 County Road 5840 in Shallowater, Texas; 0.04 mg/L at 8014 County Road 5840 in Shallowater, Texas; and 0.00 mg/L at 8226 County Road 5830 in Shallowater, Texas.
 - ii. At Plott Acres, the free chlorine residual at the time of the investigation was 0.13 mg/L at 8604 County Road 6440 near Lubbock, Texas; and 0.14 mg/L at 2103 North County Road 1440 near Lubbock, Texas.
 - iii. At Town North Estates, the free chlorine residual at the time of the investigation was between .001 and .002 mg/L at 6823 County Road 1630 in Shallowater, Texas; and .003 mg/L at

³ Five separate complaints were received on April 20, 2021; the first complaint came in at approximately 10:00am. Complaints were about water outages, low chlorine, low water pressure, and inability to contact an operator. Complaints were received for all four water systems.

6909 County Road 6130 in Shallowater, Texas.

- b. Failed to have a licensed operator on site, in violation of 30 Tex. ADMIN. CODE § 290.46(e). Investigators could not identify a person at any of the four public water systems that was serving as an operator.
- 9. The Utility failed to issue a Boil Water Notice ("BWN") to the customers of Town North Village after the April 20, 2021 water outage, in violation of 30 TEX. ADMIN. CODE § 290.46(q).
- 10. On April 23, 2021, The Lubbock Regional Office posted BWNs at all four systems of the Utility due to the water outage at Town North Village and the failure to maintain minimum disinfectant residual at Town North Village, Town North Estates, and Plott Acres.
- 11. The TCEQ alleges that the Utility has (1) failed to provide appropriate water treatment resulting in potential health hazards; (2) failed to adequately maintain facilities, resulting in potential health hazards, extended outages, and repeated service interruptions; (3) failed to provide customers notice of a potential health hazard; and (4) demonstrated a pattern of failing to respond to the TCEQ or the Utility's customers.
- 12. No other source of water is available to the more than 25 people whose water is supplied by the Utility.
- 13. A potential health hazard exists as a result of the Utility's inability to provide continuous and adequate service. A licensed operator is immediately required to ensure the quality of the water in the State and to ensure the Utility operates in a safe manner and meets requirements in the Texas Water Code, the Texas Health and Safety Code, and TCEQ rules. Therefore, a temporary manager is necessary to assume operations of the Utility to ensure the quality of the water meets TCEQ rule requirements and complies with the Texas Water Code as well as the Texas Health and Safety Code, and is safe for public use and consumption.
- 14. Intermediary Solutions Holdings LLC ("Intermediary Solutions") has agreed to serve as temporary manager of the Utility. Intermediary Solutions has designated Mr. Brian Parker as their point of contact. Mr. Parker can be reached by telephone at (214) 799-5156, and by mail at 5 Sawgrass Court, Frisco, Texas 75034. ⁵
- 15. This Emergency Order is necessary to ensure that continuous and adequate water service is provided to the customers of the Utility to effectuate the purposes of the Texas Water Code and the Texas Health and Safety Code.

II. CONCLUSIONS OF LAW

1. As evidenced by Findings of Fact Nos. 1 through 3, The Estate of Marion J.

Smith owns the retail public utility as defined in Tex. WATER CODE § 13.002(19).

- 2. Findings of Fact Nos. 5 through 13 show that as of the date of the signing of this Emergency Order the Utility has been abandoned and that the appointment of a temporary manager is justified as defined in Tex. WATER CODE §§ 13.412(f) and 13.4132 and 30 Tex. ADMIN. CODE § 291.142 (a) and (c).
- 3. TEX. WATER CODE § 13.4132 authorizes the Commission to appoint a willing person to temporarily manage and operate a utility if the utility has discontinued service or abandoned operations or the provision of services as defined by Tex. WATER CODE § 13.412.
- 4. TEX. WATER CODE § 5.507 provides that the Commission may issue an Emergency Order appointing a willing person to temporarily manage and operate a utility under TEX. WATER CODE § 13.4132.

- 6. TEX. WATER CODE § 5.501(c) and 30 TEX. ADMIN CODE §§ 35.12 and 291.143(a) authorize the TCEQ Executive Director to issue this Emergency Order.
- 7. TEX. WATER CODE §§ 5.501 and 5.507 and 30 TEX. ADMIN. CODE § 291.143(a) authorize the Executive Director to appoint a person to temporarily manage and operate a utility that has discontinued or abandoned operations.
- 8. TEX. WATER CODE § 13.4132 provides to the temporary manager the powers and duties necessary to ensure continued operation of the utility and the provision of continuous and adequate services to customers including the power and duty to read meters, bill for services, collect revenues, disburse funds, access all system components, and request rate increases.
- 9. Notice of the Emergency Order, once it has been issued, is adequate if the notice is mailed or hand delivered to the last known address of the Utility's headquarters, in accordance with Tex. WATER CODE § 5.507. The last known address for Margenell Smith, Executor of the Estate of Marion J. Smith is set forth in Finding of Fact No. 4.

III. ORDER

- 1. This Emergency Order shall be effective on the date it is executed by the TCEQ Executive Director, i.e. May 5, 2021.
- 2. Immediately upon the effective date of this Emergency Order, Intermediary Solutions Holdings LLC is hereby appointed to temporarily manage and operate the Utility.

- Intermediary Solutions shall give the Executive Director an inventory of all Utility property received within sixty (60) days of the effective date of this Emergency Order.
- 6. Intermediary Solutions' requirement to post financial assurance with the TCEQ in an amount and type acceptable to the Executive Director has been waived by the Executive Director pursuant to 30 Tex. ADMIN. CODE § 291.143(c).
- 7. Intermediary Solutions' compensation will come from Utility revenues in the amount of twelve dollars (\$12.00) per month per connection.
- 8. Intermediary Solutions shall report to the Executive Director on a monthly basis in accordance with 30 Tex. ADMIN. CODE § 291.143(h).
- 9. Pursuant to Tex. Water Code § 5.504, the Commission will consider whether to affirm, modify or set aside this Emergency Order at its regular Agenda meeting on June 30, 2021 at 9:30 a.m., at TCEQ Park 35 Complex, 12118 North I-35, Building E, Room 2015, Austin, Texas.⁶ At the June 30, 2021 Agenda meeting, Margenell Smith, Executor of the Estate of Marion J. - On April 20, 2021, the TCEQ Lubbock Regional office received numerous complaints of a water outage at Town North Village; complainants also reported that they had been unable to get in contact with anyone representing the Utility in weeks.¹
- 6. On the evening of April 20, 2021, a TCEQ investigator confirmed that there was a water outage at Town North Village and documented that there was no water pressure at the system. The Investigator determined that the outage was caused when electric power was shut off to the system due to nonpayment of electric bills.
- 7. In response to the complaints, the Lubbock Regional office investigated the situation and found that the listed owner and operator of the Utility, Marion J. Smith, had passed away in January of 2021. Investigators also found that at the time of Marion Smith's death the Utility was being operated by Jimmy Midkiff, and that during the spring of 2021 Mr. Midkiff suffered a severe medical emergency causing him to cease operating the Utility completely.⁴
- 8. On April 22, 2021, a TCEQ investigator conducted investigations at all four public water systems of the Utility. The investigator documented that the Utility:
 - a. Failed to maintain a minimum disinfectant residual throughout the distribution system, in violation of 30 Tex. ADMIN. CODE § 290.110(b)(4).
 - At Town North Village, the free chlorine residual at the time of the investigation was 0.03 milligram per liter (mg/L) at 7916 County Road 5840 in Shallowater, Texas; 0.04 mg/L at 8014 County Road 5840 in Shallowater, Texas; and 0.00 mg/L at 8226 County Road 5830 in Shallowater, Texas.
 - At Plott Acres, the free chlorine residual at the time of the investigation was 0.13 mg/L at 8604 County Road 6440 near Lubbock, Texas; and 0.14 mg/L at 2103 North County Road 1440 near Lubbock, Texas.
 - iii. At Town North Estates, the free chlorine residual at the time of the investigation was between .001 and .002 mg/L at 6823 County Road 1630 in Shallowater, Texas; and .003 mg/L at 6909 County Road 6130 in Shallowater, Texas.
 - b. Failed to have a licensed operator on site, in violation of 30 Tex. ADMIN. CODE § 290.46(e). Investigators could not identify a person at any of the four public water systems that was serving as an operator.
- 9. The Utility failed to issue a Boil Water Notice ("BWN") to the customers of Town North Village after the April 20, 2021 water outage, in violation of 30 Tex. ADMIN. CODE § 290.46(q).
- 10. On April 23, 2021, The Lubbock Regional Office posted BWNs at all four systems of the Utility due to the water outage at Town North Village and the failure to maintain minimum disinfectant residual at Town North Village, Town North Estates, and Plott Acres.
- 11. The TCEQ alleges that the Utility has (1) failed to provide appropriate water treatment resulting in potential health hazards; (2) failed to adequately maintain facilities, resulting in potential health hazards, extended outages, and repeated service

³ Five separate complaints were received on April 20, 2021; the first complaint came in at approximately 10:00am. Complaints were about water outages, low chlorine, low water pressure, and inability to contact an operator. Complaints were received for all four water systems.

interruptions; (3) failed to provide customers notice of a potential health hazard; and (4) demonstrated a pattern of failing to respond to the TCEQ or the Utility's customers.

- 12. No other source of water is available to the more than 25 people whose water is supplied by the Utility.
- 13. TCEQ Appointed Intermediary Solutions Holdings LLC ("Intermediary Solutions") as temporary manager for the Utility through an Emergency Order issued on May 5, 2021, and affirmed by the Commission on June 30, 2021, for the purpose of providing continuous and adequate water service to customers. Intermediary Solutions appointment as Temporary manager expired on November 1, 2021.
- 14. During Intermediary Solutions' first term as Temporary Manager, Intermediary Solutions installed new self-contained chlorination systems at all four systems, started maintaining a minimum disinfectant residual throughout the distribution system of all four water systems, and made various repairs necessary for the maintenance of the systems. As Temporary Manager, Intermediary Solutions has provided continuous and adequate water service to the customers of the four water systems owned by the Estate of Marion J. Smith.
- 15. A potential health hazard exists as a result of the Utility's inability to provide continuous and adequate service. A licensed operator is immediately required to ensure the quality of the water in the State and to ensure the Utility operates in a safe manner and meets requirements in the Texas Water Code, the Texas Health and Safety Code, and TCEQ rules. Therefore, a temporary manager is necessary to assume operations of the Utility to ensure the quality of the water meets TCEQ rule requirements and complies with the Texas Water Code as well as the Texas Health and Safety Code, and is safe for public use and consumption.
- 16. Intermediary Solutions has agreed to serve as temporary manager of the Utility. Intermediary Solutions has designated Mr. Brian Parker as their point of contact. Mr. Parker can be reached by telephone at (214) 799-5156, and by mail at 5 Sawgrass Court, Frisco, Texas 75034. 5
- 17. This Emergency Order is necessary to ensure that continuous and adequate water service is provided to the customers of the Utility to effectuate the purposes of the Texas Water Code and the Texas Health and Safety Code.

II. CONCLUSIONS OF LAW

- 1. As evidenced by Findings of Fact Nos. 1 through 3, The Estate of Marion J. Smith owns the retail public utility as defined in Tex. WATER CODE § 13.002(19).
- 2. Findings of Fact Nos. 5 through 15 show that as of the date of the signing of this Emergency Order the Utility has been abandoned and that the appointment of a temporary manager is justified as defined in Tex. WATER CODE §§ 13.412(f) and 13.4132 and 30 Tex. Admin. Code § 291.142 (a) and (c).
- 3. Tex. Water Code § 13.4132 authorizes the Commission to appoint a willing person to temporarily manage and operate a utility if the utility has discontinued service or abandoned operations or the provision of services as defined by Tex. Water Code § 13.412.

- 4. Tex. Water Code § 5.507 provides that the Commission may issue an Emergency Order appointing a willing person to temporarily manage and operate a utility under Tex. Water Code § 13.4132.
- 5. This Emergency Order may be issued without notice or hearing pursuant to Tex. WATER CODE § 5.501(b) and 30 Tex. ADMIN. CODE § 35.25.
- 6. TEX. WATER CODE § 5.501(c) and 30 TEX. ADMIN CODE §§ 35.12 and 291.143(a) authorize the TCEQ Executive Director to issue this Emergency Order.
- 7. Tex. Water Code §§ 5.501 and 5.507 and 30 Tex. Admin. Code § 291.143(a) authorize the Executive Director to appoint a person to temporarily manage and operate a utility that has discontinued or abandoned operations.
- 8. TEX. WATER CODE § 13.4132 provides to the temporary manager the powers and duties necessary to ensure continued operation of the utility and the provision of continuous and adequate services to customers including the power and duty to read meters, bill for services, collect revenues, disburse funds, access all system components, and request rate increases.
- 9. Notice of the Emergency Order, once it has been issued, is adequate if the notice is mailed or hand delivered to the last known address of the Utility's headquarters, in accordance with Tex. WATER CODE § 5.507. The last known address for Margenell Smith, Executor of the Estate of Marion J. Smith is set forth in Finding of Fact No. 4.

III. ORDER

- 1. This Emergency Order shall be effective on the date it is executed by the TCEQ Executive Director, i.e. November 2, 2021.
- 2. Immediately upon the effective date of this Emergency Order, Intermediary Solutions Holdings LLC is hereby appointed to temporarily manage and operate the Utility.
- 3. Intermediary Solutions shall serve as temporary manager until 180 days after the effective date of this Emergency Order i.e. May 1, 2022.
- 4. Intermediary Solutions is authorized to exercise those powers and duties necessary to ensure the continued operations of the Utility and the provision of continuous and adequate services to customers, including the powers and duties set forth in Tex. WATER CODE § 13.4132.
- 5. Intermediary Solutions shall give the Executive Director an inventory of all Utility property received within sixty (60) days of the effective date of this Emergency Order.
- 6. Intermediary Solutions' requirement to post financial assurance with the TCEQ in an amount and type acceptable to the Executive Director has been waived by the Executive Director pursuant to 30 Tex. ADMIN. CODE § 291.143(c).
- 7. Intermediary Solutions' compensation will come from Utility revenues in the amount of twelve dollars (\$12.00) per month per connection.
- 8. Intermediary Solutions shall report to the Executive Director on a monthly basis in accordance with 30 Tex. ADMIN. CODE § 291.143(h).
- 9. Pursuant to Tex. Water Code § 5.504, the Commission will consider whether to affirm,

modify or set aside this Emergency Order at its regular Agenda meeting on January 12, 2022 at 9:30 a.m., at TCEQ Park 35 Complex, 12118 North I-35, Building E, Room 2015, Austin, Texas. At the January 12, 2022 Agenda meeting, Margenell Smith, Executor of the Estate of Marion J. Smith, may request an evidentiary hearing pursuant to 30 Tex. ADMIN. CODE § 35.25(c) for the purpose of presenting evidence and cross-examining witnesses regarding whether to affirm, modify, or set aside this Emergency Order.

10. The Chief Clerk shall provide a copy of this Emergency Order to each of the parties.
