**COMMISSION STAFF'S REQUEST FOR EXTENSION**

On April 21, 2022, Sater, LP (Sater) filed a petition for streamlined expedited release from Marilee Special Utility District's (Marilee SUD) water Certificate of Convenience and Necessity (CCN) No. 10150 under Texas Water Code (TWC) § 13.2541 and 16 Texas Administrative Code (TAC) § 24.245(h). Sater asserts that the land to be released is at least 25 contiguous acres, is not receiving water service, and is located in Collin County, Texas which is a qualifying county. Sater filed supplemental information on May 6, 2022.

On February 1, 2023, the administrative law judge (ALJ) filed Order No. 4, establishing a deadline of February 8, 2023 for the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file its appraiser's report. Therefore, this pleading is timely filed.

**I. REQUEST FOR EXTENSION**

Pursuant to 16 TAC § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff is still working with the appraiser and needs additional time to prepare filing its final report on the appraisal. As such, Staff respectfully requests that the deadline to file its appraiser's report be extended until February 15, 2023.

**II. CONCLUSION**

For the reasons detailed above, Staff respectfully recommends that the petition be approved and that the Commission issue an order consistent with this recommendation.
