**ORDER NO. 2**  
**FINDING PETITION ADMINISTRATIVELY INCOMPLETE,**  
**PROVIDING OPPORTUNITY TO CURE, PROVIDING**  
**ALTERNATIVE ADDRESSES, AND RESTYLING**

This Order addresses the April 21, 2022 petition of Maple View Development, LLC to amend Orbit Systems, Inc.'s certificate of convenience and necessity (CCN) number 11982 in Brazoria County by expedited release. On May 19, 2022, Maple View Development filed letters and attachments demonstrating returned mail from the CCN holder, Orbit Systems, and requesting an alternative address. Additionally, Maple View clarified that Civitas should be removed from its name.

On May 20, 2022, Commission Staff filed recommendations on the administrative completeness of the petition, alternative addresses for Orbit Systems, and requested the case be restyled.

The administrative law judge (ALJ) finds the petition administratively incomplete for the reasons described in the May 20, 2022 memorandum of Jolie Mathis, attached to Commission Staff's recommendation. Additionally, Commission Staff provided alternative addresses for Orbit Systems.

The following procedural schedule applies for continued processing:

Deadline for petitioner to file information to cure deficiencies identified in Commission Staff's memorandum	June 20, 2022
Deadline for Commission Staff to file a supplemental recommendation on administrative completeness of the petition and sufficiency of notice and propose procedural schedule	July 20, 2022

A deadline for Orbit Systems to file a response to the petition will be established in a subsequent order.<sup>1</sup> Additional deadlines will be established if the petition is deemed administratively complete.

This docket is restyled as reflected in this Order.
