**COMMISSION STAFF’S RECOMMENDATION**

On May 4, 2022, DG Harvest Solar, LLC (DG Harvest) filed an application to amend its renewable energy credit (REC) generator certification under 16 Texas Administrative Code (TAC) § 25.173(o). DG Harvest stated that an amendment to the REC generator certificate is necessary to provide a name change from DG Central 1, LLC to DG Harvest Solar, LLC. DG Harvest Solar is registered with the Public Utility Commission of Texas (Commission) as a power generation company under registration number 20623. DG Harvest Solar filed supplemental information on May 4, 2022.

**I. STAFF RECOMMENDATION**

Commission Staff (Staff) has reviewed the application and as supported by the attached memorandum of Grace Godines of the Customer Protection Division, recommends that DG Harvest has satisfied the requirements of 16 TAC § 25.173(o). Specifically, all information required under 16 TAC § 25.173(o)(1) is present in the May 4, 2022, application. Therefore, Staff recommends the application be approved, and that DG Harvest’s registration be updated to the new name of FELPS 4 – Floresville South.

**II. CONCLUSION**

Staff recommends that DG Harvest’s application be approved and respectfully requests the issuance of an order consistent with the foregoing recommendation.

### **STAFF RECOMMENDATION**

On April 28, 2022, DG Harvest Solar, LLC (DG Harvest or the Company) filed an application to amend its renewable energy credit (REC) generator under 16 Texas Administrative Code (TAC) § 25.173(o). On May 4, 2022 the Company filed supplemental information to clarify and correct its application. DG Harvest stated that an amendment to the REC generator certificate is necessary to provide a name change from DG Central 1, LLC to DG Harvest Solar, LLC. DG Harvest is registered with the Commission as a power generation company under registration number 20623.

After reviewing DG Harvest’s application, I find that the Company has provided all of the information required under 16 TAC § 25.173(o)(1). Therefore, I recommend that the FELPS 4 – Floresville South facility application for an amendment to its REC generator certification be granted. The Commission records shall be revised to reflect the updated name change.

Any subsequent changes to the information in the application are to be submitted to the Commission as supplements to this filing within 30 days of such changes.
