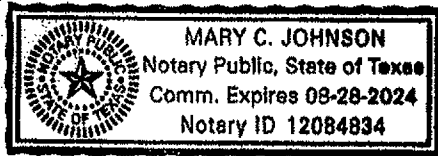
BEFORE ME, the undersigned authority, on this day personally appeared J. Rich Sparks, who being by me first duly sworn, on oath, deposed and said the following:

1. My name is J. Rich Sparks. I am employed by Southwestern Public Service Company ("SPS") as Regulatory Case Specialist. I am authorized to make this affidavit and I have personal knowledge of the facts stated herein.
2. On April 29, 2022, SPS filed with the Public Utility Commission of Texas an application to adjust its Energy Efficiency Cost Recovery Factor ("EECRF"). The application has been assigned Docket No. 53540.
3.
