## **COMMISSION STAFF'S REQUEST FOR EXTENSION**

On May 6, 2022, VPTM Cross Creek LB, LLC (VPTM Cross Creek LB) filed a petition for streamlined expedited release from Marilee Special Utility District's (Marilee) sewer Certificate of Convenience and Necessity (CCN) No. 10150 under Texas Water Code (TWC) § 13.2541 and 16 Texas Administrative Code (TAC) § 24.245(h). VPTM Cross Creek LB asserts that the land is at least 25 contiguous acres, is not receiving sewer service, and is located in Collin County, which is a qualifying county.

On June 7, 2022, the administrative law judge (ALJ) filed Order No. 2, establishing a deadline of July 5, 2022, for the Staff of the Public Utility Commission of Texas (Staff) to file a recommendation on final disposition. Therefore, this pleading is timely filed.

## I. REQUEST FOR AN EXTENSION

Under 16 TAC § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff requests this extension so that it may complete its review of Marilee's response filed on June 27,2022. Accordingly, Staff respectfully requests the entry of an order extending Staff's deadline to file a recommendation on final disposition to July 19, 2022.

#### II. CONCLUSION

Staff respectfully requests an order consistent with the foregoing request.
