**JOINT NOTICE OF SETTLEMENT
AND REQUEST FOR INFORMAL DISPOSITION**

Pursuant to 16 Tex. Admin. Code § 16.245(i)(1), this Notice is to inform the Public Utility Commission (“PUC”) that MSEC Enterprises, Inc. (the former CCN holder in this matter) and the Benchmark Acquisitions, LLC (the Petitioner and landowner) have agreed on the amount of compensation to be paid to the former CCN holder. The amount of the compensation to be paid is \$32,000. This amount should not be used or relied upon as setting any precedent for the valuation of decertification as it was reached in the context of a settlement.
