MONTGOMERY COUNTY LAND INVESTMENTS, INC.'S RESPONSE TO THE COMMISSION STAFF'S RECOMMENDATION ON ADMINISTRATIVE COMPLETENESS AND NOTICE

On June 13, 2022, the Public Utility Commission of Texas Staff (Commission Staff) requested revised maps of the property to be released from T & W Water Service Company's water certificate of convenience and necessity. Order No. 2 requires that the revised maps and associated digital shapefiles and data be submitted by July 13, 2022. Therefore, this response is timely filed.

Attached as Exhibit 1 are the required revised maps and digital data. Please note that the digital data calculates the acreage of the area to be 2.798 acres smaller than the acreage identified in the deeds for the property. This discrepancy is likely because the digital data used to create the maps came from the Montgomery County Appraisal District files and is not the data associated with the field note descriptions attached to the deeds. Montgomery County Land Investments, Inc. has not been able to obtain the digital files from the surveyor who prepared the field note descriptions. Because the digital data calculates less acreage than the deeds, there is no issue with Montgomery County Land Investments, Inc. inadvertently including property that it does not own in this petition.
