COMMISSION STAFF’S STATUS REPORT

I. INTRODUCTION

On May 16, 2022, Concho Rural Water Corporation (Concho Rural) filed an application to amend its Certificate of Convenience and Necessity (CCN) in Tom Green County. Concho Rural holds water CCN No. 11361. The requested service area consists of 40 acres and 32 existing connections.

On August 22, 2022, the administrative law judge (ALJ) filed Order No. 4, establishing a deadline of January 17, 2022, for the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a status report or request to lift the abatement, as well as file comments on the administrative completeness of the application and proposed notice, and a recommendation regarding how to proceed with the application including a procedural schedule. Therefore, this pleading is timely filed.

II. REQUEST FOR CONTINUED ABATEMENT

In November 2022, Concho Rural indicated to Staff that they would submit the documents and maps necessary for Staff to make its recommendation on administrative completeness soon. However, Concho Rural never filed the necessary information. Without the necessary information, Staff is unable to make a recommendation.

Staff will need at least 30 days to review the documents and maps once they are filed. As such, Staff respectfully requests a 60-day continuance of the abatement to provide time for Concho Rural to file the needed information and for Staff to review the supplemental information Concho Rural files.

III. CONCLUSION

Staff respectfully requests that the ALJ continue the abatement of this docket as provided above, and that an order be entered consistent with the foregoing requests.
