JOINT RESPONSE TO ORDER NO. 35

I. INTRODUCTION

On October 9, 2024, the Administrative Law Judge (ALJ) issued Order No. 35 requiring a response from Orbit Systems, Inc. (Orbit) and Undine Texas Environmental, LLC (Undine) (collectively, the Applicants), along with the Staff (Staff) of the Public Utility Commission of Texas (Commission) (collectively, the Parties) by October 21, 2024. Therefore, this pleading is timely filed.

II. JOINT CLARIFICATION

Pursuant to Order No. 35, the ALJ required that the Applicants and Commission Staff clarify:

- (1) whether they conferred with Tommy Green prior to the filing of the joint motion to admit additional evidence and proposed notice of approval (the August 2024 Joint Filing) and
- (2) whether Mr. Green was involved with the preparation of the proposed notice of approval.

The Parties did not confer with Mr. Green on the Joint Motion, nor was Mr. Green involved with its preparation. In the Parties' Joint Response to Order No. 21, filed on July 7, 2023 (AIS Item No. 82), the Parties stated:

"Pursuant to [Undine's] outreach to Mr. Green on June 28, 2023, Mr. Green confirmed that he would not participate in the joint motion to admit evidence and proposed order

approving the sale and transfer to proceed (the June 2023 Joint Filing), based on his

ongoing concerns regarding the increase in rates proposed in the application."

On July 20, 2023, the ALJ issued Order No. 23 admitting the evidence submitted in the

June 2023 Joint Filing, and on July 21, 2023, the ALJ issued Order No. 24 withdrawing notice of

hearing. The ALJ later issued Order Nos. 26, 28, and 31, providing notice to all parties, which

would include Mr. Green. Furthermore, since the June 2023 Joint Filing, Mr. Green has not reached

out to Staff regarding this proceeding, has already stated his intention not to participate in this

proceeding, did not file anything in response to Order No. 28, and did not file anything in response

to Staff's recommendation on the transaction (AIS Item No. 97).

The Parties respectfully request that the ALJ consider this information in clarification of

the information previously submitted in the docket, and that the August 2024 Joint Filing be

granted.

The undersigned counsel for Undine represents that he has conferred with Orbit and with

Commission Staff, and that Orbit and Commission Staff have authorized Undine to submit

this joint response.
