COMMISSION STAFF'S RECOMMENDATION ON SUFFICIENCY OF NOTICE

On May 23, 2022, Undine Texas Environmental, LLC (Undine) and Orbit Systems, Inc. (Orbit) (collectively, Applicants) filed an application for approval of the sale, transfer, or merger of facilities and certificate rights in Brazoria County.

On July 21, 2022, the administrative law judge (ALJ) filed Order No. 3, directing the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a recommendation on the sufficiency of notice for further processing of the application by August 29, 2022. Therefore, this pleading is timely filed.

I. RECOMMENDATION ON NOTICE

Staff has reviewed the proof of notice provided by Undine and recommends that notice is sufficient. Specifically, Undine provided an affidavit of notice dated August 2, 2022, and signed by Carey A. Thomas, Senior Vice President of Undine, that notice was provided on July 28, 2022, to its current customers, neighboring utilities, and affected parties, as well as the maps that were attached to the provided notice. Therefore, Staff recommends that the notice provided by Undine be deemed sufficient for the further processing of this matter.

II. CONCLUSION

For the reasons detailed above, Staff respectfully recommends that the notice provided by Undine be found to be sufficient for the further processing of this matter.
