**ORDER NO. 6**  
**FINDING NOTICE SUFFICIENT AND**  
**ESTABLISHING PROCEDURAL SCHEDULE**

This Order addresses the sufficiency of the notice provided by Orbit Systems, Inc. and Undine Texas Environmental, LLC.

On August 16, 2022, the applicants filed the affidavit of Carey A. Thomas, senior vice president of Undine, attesting that notice, along with map, was provided to current customers, neighboring utilities and systems, and affected parties on July 28, 2022. The applicants also included the affidavit of Gloria Ashworth, business manager for The Facts, a newspaper of general circulation in Brazoria County, attesting to the publication of notice on July 28 and August 4, 2022. On August 29 and September 7, 2022, Commission Staff filed a recommendation regarding the notice, and a supplemental recommendation, respectively.

The administrative law judge finds the notice sufficient.

The following procedural schedule is established for continued processing.

Deadline for parties to respond to Commission Staff's recommendation	September 29, 2022
Deadline for parties to file a joint motion to admit evidence and proposed order approving sale and allowing transaction to proceed.	October 26, 2022
120-day deadline for the Commission to approve the sale or require a hearing	December 2, 2022 <sup>1</sup>

<sup>1</sup> Under 16 TAC § 24.239 (a) and (j), the deadline for Commission action is 120 days after the mailing or publication of notice, whichever occurs later. One hundred and twenty days after August 4, 2022 is December 2, 2022.
