COMMISSION STAFF’S REQUEST FOR EXTENSION

On May 23, 2022, Undine Texas Environmental, LLC (Undine) and Orbit Systems, Inc. (Orbit) (collectively, Applicants) filed an application for approval of the sale, transfer, or merger of facilities and certificate rights in Brazoria County. Specifically, Undine, sewer Certificate of Convenience and Necessity (CCN) No. 20682, seeks approval to acquire utility assets from Orbit under sewer CCN No. 20682.

On September 8, 2022, the administrative law judge (ALJ) filed Order No. 6, directing the Staff (Staff) of the Public Utility Commission of Texas (Commission) to either request a hearing or file a recommendation on the final sale by September 22, 2022. Therefore, this pleading is timely filed.

I. REQUEST FOR EXTENSION

Under 16 Texas Administrative Code (TAC) § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. On September 21, 2022, Undine filed supplemented information requested by Staff. Staff needs additional time to review the additional information filed by Undine before filing its recommendation on the final sale. As such, Staff respectfully requests that the deadline to file its final recommendation be extended until October 6, 2022.

II. CONCLUSION

For the reasons detailed above, Staff respectfully requests that its deadline to file its final recommendation be extended until October 6, 2022.
