**COMMISSION STAFF’S SUPPLEMENTAL RECOMMENDATION ON REVISED
NOTICE**

I. INTRODUCTION

On May 23, 2022, Undine Texas Environmental, LLC (Undine) and Orbit Systems, Inc. (Orbit) (collectively, Applicants) filed an application for approval of the sale, transfer, or merger of facilities and certificate rights in Brazoria County.

On February 3, 2023, the administrative law judge (ALJ) filed Order No. 15, directing the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a recommendation on revised notice by March 10, 2023. Therefore, this pleading is timely filed.

II. NOTICE

Staff has reviewed the proof of notice provided by Undine and recommends that notice is sufficient. Specifically, Undine provided an affidavit of notice dated February 22, 2023, and signed by Carey Thomas, Senior Vice President of Undine, that notice was provided on February 15, 2023, to its current customers, landowners, neighboring utilities, and affected parties, as well as the maps that were attached to the provided notice. Undine also provided copies of its publication and publisher’s affidavit dated February 22, 2023, showing that notice was published in *The Facts*, a newspaper of general circulation in Brazoria County, on February 14 and 21, 2023. Therefore, Staff recommends that the notice provide by Undine be deemed sufficient for further processing of this matter.

III. CONCLUSION

For the reasons detailed above, Staff respectfully recommends that Undine’s revised proof of notice be found sufficient.
