#### **COMMISSION STAFF'S REQUEST FOR EXTENSION**

On May 23,2022, Monarch Utilities I L.P. (Monarch) filed an application for a certificate of convenience and necessity name change and a minor tariff change. Specifically, Monarch seeks to change its name to Texas Water Utilities, L.P. and update its application of service, which is included in its water tariffs as Appendix B, to reflect changes to its tapping process consistent with the Commission's final order in Docket No. 50944.<sup>1</sup>

On August 26, 2022, the administrative law judge (ALJ) filed Order No. 6, requiring the parties, including Staff (Staff) of the Public Utility Commission of Texas (Commission), to file joint proposed findings of fact and conclusions of law by October 24, 2022.

## I. REQUEST FOR EXTENSION

Under 16 Texas Administrative Code (TAC) § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. After filings its latest recommendation, Staff noticed it inadvertently omitted some information. Staff must prepare a revised recommendation to correct the mistake. Thus, Staff respectfully requests that the parties' deadline to file joint proposed findings of fact and conclusions of law be extended to November 2, 2022.

### **II. CONCLUSION**

For the reasons discussed above, Staff respectfully requests the entry of an order extending the parties' deadline to file joint proposed findings of fact and conclusions of law be extended to November 2, 2022.
