COMMISSION STAFF'S REQUEST FOR EXTENSION

I. INTRODUCTION

On May 26, 2022, Clearwater Investments, LLC (Clearwater) and Knob Hill Water System (Knob Hill) (collectively, Applicants) filed an application for the sale and transfer of facilities and certificate rights in Denton County under the provisions of Texas Water Code § 13.301 and 16 Texas Administrative Code § 24.239.

On November 28, 2022, the administrative law judge (ALJ) filed Order No. 4, requiring the Staff (Staff) of the Public Utility Commission of Texas (Commission) and the Applicants, (collectively, Parties) to file a joint response clarifying or confirming the full and correct names of the buyer and seller, along with a corrected proposed notice of approval by December 2, 2022. Therefore, this pleading is timely.

II. REQUEST FOR EXTENSION

Under 16 Texas Administrative Code (TAC) § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff needs additional time to confer with the Applicants regarding confirmation of the correct names of the buyer and seller in the transaction. As such, in order to allow time for Staff to continue discussing this issue and to review additional information needed from the parties, Staff respectfully requests that the deadline to file to file its joint response with the Applicants be extended until December 16, 2022.

III. CONCLUSION

For the reasons detailed above, Staff respectfully requests that its deadline to file a joint response clarifying or confirming the full and correct names of the buyer and seller, along with a corrected proposed notice of approval be extended until December 16, 2022.
