COMES NOW, the Steering Committee of Cities Served by Oncor (Cities) and files this Motion to Intervene as a party to this proceeding. In support of its Motion, Cities shows as follows:

1. Cities is made up of municipalities located within the service territory of Oncor Electric Delivery Company, LLC (Oncor). A list of Steering Committee cities is included as Attachment A.

2. On May 31, 2022, Oncor filed an application to adjust its energy efficiency cost recovery factor (EECRF). Cities' members, as well as their residents and businesses, may be adversely impacted by the relief requested by Oncor. Therefore, Cities has a justiciable interest in this proceeding.

3. Additionally, Cities has standing pursuant to Public Utility Regulatory Act (PURA) § 33.025.¹
